BOARD OF INVESTIGATION INTO THE SALDANHA STEEL PROJECT

A Board of Investigation has been appointed by the Minister of Environmental Affairs and Tourism to advise him on the evaluation of the matter.

The Board of Investigation must advise the Minister on:

- ▶ The status and implication of the relative decisions that were taken in the past by the government authorities, and in accordance with which certain developments in the Saldanha Bay area and undertakings that have already taken place;
- ▶ An evaluation of the objections raised against the proposed industrial development.
- ▶ which powers the respective authorities have in this regard. [This include the relevance of section 31 (A) of the Environment Conservation Act R1 989.]
- ▶ Any other issue which in its opinion is a relevant consideration in the evaluation of the matter.

The Board of Investigation invites all interested and affected parties to submit written evidence to reach the Board not later than 14 July 1995.
