The South African Roads Board hereby, in terms of section 9 (4) (c) of the National Roads Act, 1971 (Act No. 54 of 1971), as amended, makes known that the amounts of toll levied in terms of section 9 (1) (b) of the said Act at the Wilge, Tugela, Mooi and Mariannhill Toll Plazas in respect of motorcycles have been altered for the period mentioned in the Schedule, by the Minister of Transport in terms of sections 9 (4) (a) and 9 (4) (d) thereof and that the said amounts shall be levied in terms of sections 9 (4) (b) (ii) and (iii) thereof, as set out in the Schedule hereto.
