SOUTH AFRICAN ROADS BOARD

NATIONAL ROUTE 1, SECTIONS 23-26: WARM-BATHS-PIETERSBURG: REPEAL OF PROCLAMATION No. 326 OF 1986 (KRANSKOP TOLL ROAD: DISTRICT OF WATERBERG); AND DECLARATION OF A TOLL ROAD FROM WARMBATHS TO PIETERSBURG: NORTHERN PROVINCE

In terms of section 9 (1) (a) of the National Roads Act, No. 54 of 1971, the South African Roads Board hereby withdraws Proclamation No. 326 of 1986, and declares that the portion of National Road N1, Sections 23-26, from km 28,6 on Portion 117 of Roodekuil 496 KR, at the Settlers Interchange and as declared by Proclamation No. 186 of 1973, Government Notice No. 2029 of 1990, Proclamation No. 39 of 1984, Government Notices Nos. 2296 of 1993, as amended, and 1010 of 1993, Proclamation No. 181 of 1975, as amended, and Government Notices Nos. 43 of 1994 and 2139 of 1994, shall be a toll road.
