GENERAL NOTICE IN TERMS OF RESTITUTION OF LAND RIGHTS ACT, 1994 (ACT No. 22 OF 1994)

Notice is hereby given in terms of section 11 (1) of the Restitution of Land Rights Act, 1994 (Act No. 22 of 1994), that a claim for the restitution of land rights on—

the farm Groote Springfontyn 1, Cape Division, measuring 1205,1405 (one thousand two hundred and five comma one four nought five) hectares, held by Deed of Title T17725/1976,

has been submitted during 1992 and subsequently in terms of the above-mentioned Act on 27 July 1995 by Tim du Toit & Company Incorporated on behalf of former land owner, Lochline Tertia Bekker and Luceel Jeanette Beukes to the Regional Land Claims Commissioner (Western and Northern Cape) and that the Commission on Restitution of Land Rights will investigate the claim in terms of the provisions of the Act in due course.
