AUCTION OF LAND

SOUTH AFRICAN ROADS BOARD

The South African Roads Board (SARB) intends selling the following property by public auction on 29 September 1995 at 11:00:

An unsurveyed portion of Portion 201 of the farm Witkoppen 194 IQ, measuring approximately 6 120 square metres.

The auction will be held on the property. The successful bidder will be responsible for the payment of ten per cent of the total purchase amount on the day of the auction by means of a bank guaranteed cheque. The SARB is not obliged to accept the highest or any other bid. The sale of the property is subject to confirmation by the SARB. Immediately after the auction, the successful bidder shall sign the Agreement of Sale, available on request from the undermentioned.

The sale of the property is further subject to the following conditions:

- (a) As the property has no access, the purchaser, if not an adjoining owner, shall be responsible to provide access to the property and submit written proof thereof to the SARB within six months of the date of auction, failing which, the sale shall be deemed ab initio nul and void and the deposit forfeited.
- (b) The property is sold subject to a lease expiring on 30 September 2009.
