**ACT**

**To amend the Public Holidays Act, 1994, so as to empower the President to declare any day to be a public holiday; and to provide for matters connected therewith.**

*(English text signed by the President.)  
(Assented to 28 September 1995.)*

**B**E IT ENACTED by the Parliament of the Republic of South Africa, as follows:—

**Amendment of section 1 of Act 36 of 1994**

1. Section 1 of the Public Holidays Act, 1994 (hereinafter referred to as the principal Act), is hereby amended by the substitution in subsection (1) for the definition of “public holidays” of the following definition:

“ ‘public holidays’ means the days mentioned in Schedule 1 and any other day declared to be a public holiday under section 2A;”.

**Insertion of section 2A in Act 36 of 1994**

2. The following section is hereby inserted in the principal Act after section 2: 10

**“Declaration of public holidays**

**2A. The President may by proclamation in the Gazette declare any day to be a public holiday throughout the Republic or any part thereof.”.**

3. This Act shall be called the Public Holidays Amendment Act, 1995.

**D**AAR WORD BEPAAL deur die Parlement van die Republiek van Suid-Afrika, soos volg:—

**Wysiging van artikel 1 van Wet 36 van 1994**

1. Artikel 1 van die Wet op Openbare Vakansiedae, 1994 (hieronder die Hoofwet genoem), word hierby gewysig deur in subartikel (1) die omskrywing van "openbare vakansiedae" deur die volgende omskrywing te vervang:  
"openbare vakansiedae" die dae genoem in Bylae 1 en enige ander dag kragtens artikel 2A tot 'n openbare vakansiedag verklaar;".

**Invoeging van artikel 2A in Wet 36 van 1994**

- 10 2. Die volgende artikel word hierby in die Hoofwet ingevoeg na artikel 2:

**"Verklaring van openbare vakansiedae"**

**2A. Die President kan, by proklamasie in die Staatskoerant, enige dag tot 'n openbare vakansiedag oral in die Republiek of in enige deel daarvan verklaar."**
