NOTICE 1177 OF 1995 DEPARTMENT OF CONSTITUTIONAL DEVELOPMENT

PORTFOLIO COMMITTEE ON CONSTITUTIONAL AFFAIRS (NATIONAL ASSEMBLY): DRAFT OF NEW TRANSITIONAL LEGISLATION ON LOCAL GOVERNMENT

The Committee regards the contributions of the public as crucial in the drafting of new transitional legislation on local government.

On Wednesday, 13 September 1995, the Committee resolved that as a first step in the legislative process, the Committee in conjunction with the Department of Constitutional Development hold public hearings to identify the practical problems currently experienced by administrators and councillors on local government level, as well as by MECs and administrators on provincial level, as regards the effective functioning and regulation of local government.

The public hearings are scheduled to be held on 22, 23 and 24 November 1995 in the Old Assembly Chamber of Parliament, Cape Town.

Written representations should be submitted to Parliament by not later than Wednesday, 15 November 1995.
