PUBLIKASIES OF VOORWERPE

PROHIBITION ON POSSESSION OF UNDESIRABLE
PUBLICATIONS OR OBJECTSVERBOD OP BESIT VAN ONGEWENSTE
PUBLIKASIES OF VOORWERPE

A committee referred to in section 4 of the Publications Act, 1974 (the Act), has decided under section 11 (2) of the Act that the undermentioned publications are undesirable within the meaning of section 47 (2) of the Act, and has under section 9 (3) of the Act prohibited the possession of the said publications. The said prohibitions were confirmed by the Publications Appeal Board under section 9 (5) of the Act.
