SOUTH AFRICAN ROADS BOARD

NATIONAL ROUTE 1, SECTIONS 1 AND 2: REPEAL OF GOVERNMENT NOTICE No. 2878 OF 1987, AND RE-DECLARATION OF A TOLL ROAD FROM KM 55,153 OF NATIONAL ROUTE 1, SECTIONS 1 AND 2, TO FLORENCE (EXTENSION OF THE HUGUENOT TOLL ROAD): PROVINCE OF THE WESTERN CAPE

In terms of section 9 (1) (a) of the National Roads Act, 1971 (Act No. 54 of 1971), the South African Roads Board hereby withdraws Government Notice No. 2878 of 31 December 1987, and declares that the section of National Road commencing, so as to exclude the off-ramp, at Km 55,153 of National Route 1, Sections 1 and 2, and as declared by Proclamation No. 255 of 1987 (as amended) and Government Notices Nos. 1371 of 1993 and 3169 of 1992, ending at Points L1 and R1 of the last-mentioned Government Notice, shall be a toll road (Huguenot Toll Road).
