MINISTRY OF EDUCATION

PROPOSED ALTERATIONS TO THE RIGHTS, POWERS AND FUNCTIONS OF PUBLIC SCHOOL GOVERNING BODIES

Public consultative meetings to discuss the proposed rights, powers and functions of school governing bodies will be held at venues in **Gauteng, Mpumalanga** and the **Eastern Cape** in June 1996.

The meetings will be based on the draft **South African Schools Bill**, and the document, **Proposed alterations to the rights, powers and functions of public school governing bodies**, which were published in the *Government Gazette* in April. Subsequently, copies of the documents were mailed to all public school governing bodies.

Representatives of school governing bodies are invited to attend these meetings to discuss the two documents.

The venues for the meetings which are scheduled for July 1996 for KwaZulu-Natal, will be published later.
