ACT

To amend or repeal South African legislation, so as to substitute or delete all references to “South-West Africa”; and to provide for matters connected therewith.

(Assented to 27 September 1996.)*

BE IT ENACTED by the Parliament of the Republic of South Africa, as follows:—

1. The laws mentioned in the second column of the Schedule are hereby amended or repealed to the extent set out in the third column of the Schedule. 5
