ACT

To provide for the rationalisation of certain laws relating to explosives, internal security, intimidation and the regulation of gatherings; to that end to amend certain laws relating to those matters; to repeal certain laws relating to those matters which apply in the former national territories of the former entities of Transkei, Bophuthatswana, Venda and Ciskei; to extend the operation of certain laws of the Republic relating to those matters to the whole of the national territory of the Republic, including the former national territories of the said entities; and to provide for matters connected therewith.

(Afrikaans text signed by the President.)
(Assented to 12 November 1996.)

BE IT ENACTED BY the Parliament of the Republic of South Africa, as follows:—

Amendment of laws

1. The laws of the Republic specified in Schedule 1 are hereby amended to the extent indicated in the third column thereof. 5

Repeal of laws

2. The laws specified in Schedule 2 are hereby repealed to the extent indicated in the third column thereof.

Extension of laws of Republic

3. The operation of the laws mentioned in Schedule 3 is hereby extended to all areas 10
in the Republic, including the areas which previously constituted the national territories of Transkei, Bophuthatswana, Venda and Ciskei, and such laws, and all regulations and notices made or issued in terms of such laws, shall replace all laws, regulations and notices relating to explosives, internal security, intimidation and the regulation of gatherings applying in such areas. 15

Om voorsiening te maak vir die rasionalisering van sekere wette betreffende ontplofbare stowwe, binnelandse veiligheid, intimidasie en die regulering van byeenkomste; te dien einde sekere wette betreffende daardie aangeleenthede te wysig; sekere wette betreffende daardie aangeleenthede wat van toepassing is in die voormalige nasionale gebiede van die voormalige entiteite van Transkei, Bophuthatswana, Venda en Ciskei, te herroep; die gelding van sekere wette van die Republiek betreffende daardie aangeleenthede uit te brei tot die hele nasionale gebied van die Republiek, met inbegrip van die voormalige nasionale gebiede van gemelde entiteite; en om voorsiening te maak vir aangeleenthede wat daarmee in verband staan.

Wysiging van wette

1. Die wette van die Republiek in Bylae 1 vermeld, word hierby gewysig in die mate 5 in die derde kolom daarvan aangedui.

Herroeping van wette

2. Die wette in Bylae 2 vermeld word hierby herroep in die mate in die derde kolom daarvan aangedui.

Uitbreiding van wette van Republiek

10 3. Die gelding van die wette in Bylae 3 vermeld, word hierby uitgebrei tot alle
gebiede in die Republiek, met inbegrip van die gebiede wat voorheen die nasionale
gebiede van Transkei, Bophuthatswana, Venda en Ciskei uitgemaak het, en sodanige
wette, en alle regulasies en kennisgewings ingevolge sodanige wette uitgevaardig of
uitgereik, vervang alle wette, regulasies en kennisgewings betreffende ontplofbare
15 stowwe, binnelandse veiligheid, intimidasie en die regulering van byeenkomste van
toepassing in sodanige gebiede.

Pending proceedings

4. (1) No provision of this Act shall affect proceedings pending in a court of law at the commencement of this Act, and such proceedings may be continued and concluded in all respects as if this Act had not been passed.

(2) Proceedings shall for the purposes of this section be deemed to be pending at commencement of this Act— 5

- (a) in the case of civil proceedings, if a summons has been issued, but judgment has not been given; 15
- (b) in the case of criminal proceedings, if the accused has pleaded but judgment and sentence have not been given and imposed. 10

Saving

5. No provision of this Act shall—

- (a) affect the previous operation of any law repealed by section 2, or made applicable by section 3, or anything duly done or suffered under any law so made applicable or repealed; 15
- (b) affect any right, privilege, obligation or liability acquired, accrued or incurred under any law so made applicable or repealed; 20
- (c) affect any penalty, forfeiture or punishment incurred in respect of any offence committed in contravention of any law so made applicable or repealed; 20
- (d) affect any question as to whether any law was at the commencement of this Act in operation in any particular area, notwithstanding the inclusion of such law in or the omission thereof from Schedule 2 or 3; 25
- (e) affect any appointment to any office made under any law repealed by this Act, if a corresponding law mentioned in Schedule 3 also provides for such an appointment, and anything done in connection with or by virtue of any such appointment shall be deemed to have been done under such corresponding law. 25

Short title

6. This Act shall be called the Safety Matters Rationalisation Act, 1996.

Hangende verrigtinge

- 10 (b) in die geval van strafregtelike verrigtinge, indien die beskuldigde gepleit het, maar uitspraak en vonnis nog nie gegee en opgelê is nie.

Voorbehoud

5. Geen bepaling van hierdie Wet—

- 20 (c) raak enige boete, verbeurdverklaring of straf opgeloop ten opsigte van enige oortreding gepleeg in stryd met 'n wet aldus van toepassing gemaak of herroep nie;
- (d) raak enige vraag of enige wet by die inwerkingtreding van hierdie Wet in 'n besondere gebied in werking was nie, ondanks die insluiting van sodanige wet in of die weglating daarvan uit Bylae 2 of 3;
