By virtue of the powers delegated to me by the Minister of Water Affairs and Forestry, by Government Notice No. 785 of 22 April 1994, I, Claus Triebel, in my capacity as Deputy Director-General: Utilisation in the Department of Water Affairs and Forestry hereby authorise, in terms of section 62 (2H) (a) read with section 62 (2H) (b) and section 63 (11A) of the Water Act, 1956, owners of properties in the above-mentioned Government Control Areas, who have the right to the abstraction and utilisation of public water in terms of sections 62 and 63 of the Act, to construct new storage works in the said Areas and to alter or enlarge existing storage dams therein, subject to the following conditions:

- (a) Dams which impound **only** extra water from the canal or surplus water from the Pongola River are restricted to a maximum storage capacity of 100 per cent of the relevant property's annual water quota for the scheduled area thereof;
- (b) dams which impound **only** run-off water from the catchment area thereof are restricted to a maximum storage capacity of 50 per cent of the relevant property's annual water quota for the scheduled area thereof; and
- (c) dams which impound water from the canal or Pongola River, as well as run-off water from the catchment area upstream of the dam are restricted to a maximum storage capacity of 50 per cent of the relevant property's annual water quota for the scheduled area thereof, provided that prior approval for the construction or enlargement is obtained from the Regional Director: KwaZulu-Natal, Department of Water Affairs and Forestry, P.O. Box 1018, Durban, 4000 [Tel. (031) 306-1367], under the conditions he deems necessary.
