- I. AMENDMENT OF THE DESCRIPTION OF THE WILDERNESS NATIONAL LAKE AREA IN TERMS OF THE LAKE AREAS DEVELOPMENT ACT, 1975 (ACT No. 39 OF 1975)
- II. DECLARATION OF LAND TO BE PART OF THE WILDERNESS NATIONAL PARK IN TERMS OF THE NATIONAL PARKS ACT, 1976 (ACT No. 57 OF 1976)

I, Zweledinga Pallo Jordan, Minister of Environmental Affairs and Tourism, by virtue of the powers vested in me—

- (a) by section 2 (1) (b) of the Lake Areas Development Act, 1975 (Act No. 39 of 1975), hereby amend the description of the Wilderness National Lake Area as defined in the Schedule of Proclamation No. 69 which appeared in the *Government Gazette* of 2 May 1986, by excluding the land defined in the Schedule hereto from the Wilderness National Lake Area; and
- (b) by section 2B (1) (b) of the National Parks Act, 1976 (Act No. 57 of 1976), declare hereby with the concurrence of the Minister of Minerals and Energy and subject to the agreement entered into between the National Parks Board and the Wilderness District Board, the land defined in the Schedule to be part of the Wilderness National Park.
