PATENTS ACT, 1978

BUDAPEST TREATY ON THE INTERNATIONAL RECOGNITION OF THE DEPOSIT OF MICROORGANISMS FOR THE PURPOSES OF PATENT PROCEDURE

The following information is published for general notice in regard to the Budapest Treaty on the International Recognition of the Deposit of Microorganisms for the Purposes of Patent Procedure (done at Budapest on 28 April 1977 and amended on 26 September 1980):

(1) The Republic of South Africa deposited its instrument of accession to the Budapest Treaty on 14 April 1997. In terms of Article 16(2) of the Treaty, the Treaty will enter into force with respect to the Republic of South Africa on 14 July 1997;

(2) The list of the States and Intergovernmental Organisations party to the Budapest Treaty as at 14 April 1997, and the list of International Depositary Authorities recognised under Article 7 of the Budapest Treaty are set out in the Schedule.
