NOTICE IN TERMS OF SECTION 31A (1)

NEW CONSTITUTIONAL COURT COMPETITION

In terms of the powers vested in me by section 31A (1) of the Architects' Act, 1970 (Act No. 35 of 1970), I, Jeffrey Thamsanqa Radebe, Minister of Public Works, do hereby exempt any person entering for the architectural competition for the design, planning and supervision of the erection of the New Constitutional Court who is not registered as an architect in South Africa, from the operation of the provisions of sections 22 (1) (a) and (1A) (a) and the rules published in terms of section 7 (3) (c) of the said Act.

This notice shall come into operation on **15 July 1997**.
