EXCLUSION OF CERTAIN MEDICINES FROM THE OPERATION OF CERTAIN PROVISIONS OF THE MEDICINES AND RELATED SUBSTANCES CONTROL ACT, 1965 (ACT No. 101 OF 1965)

I, Johann Schlebusch, Registrar of Medicines, acting by virtue of a delegation in terms of section 34A of the Medicines and Related Substances Control Act, 1965 (Act No. 101 of 1965), hereby, in terms of section 36 of Act No. 101 of 1965, on the unanimous recommendation of the Medicines Control Council, exclude the medicines listed in the Schedule from the operation of the provisions of sections 14 and 15 of Act No. 101 of 1965 listed therein and regulations 9, 10 and 11 of the regulations made under the said Act, subject to the conditions likewise listed in the Schedule.
