It is hereby notified that the President has assented to the following Act which is hereby published for general information:—

Hierby word bekend gemaak dat die President sy goedkeuring geheg het aan die onderstaande Wet wat hierby ter algemene inligting gepubliseer word:—

No. 54 of 1997: Legal Deposit Act, 1997

No. 54 van 1997: Wet op Pliglewering, 1997.

(2) A delegation under subsection (1) shall not prevent the exercise of the power in question by the Minister himself or herself.

### Regulations

**12.** The Minister may make regulations regarding—

- (a) any matter which is required or permitted to be prescribed under this Act; and 5
- (b) generally, any matter which is necessary or expedient to be prescribed in order to achieve the objects of this Act.

### Act binds State

**13.** This Act, except section 9, shall bind the State.

### Repeal of laws

**14.** The laws mentioned in the Schedule are hereby repealed to the extent set out in the third column thereof. 10

### Short title and commencement

**15.** This Act shall be called the Legal Deposit Act, 1997, and shall come into operation on a date fixed by the President by proclamation in the *Gazette*. 15

#### **Regulasies**

- 5     **12.** Die Minister kan regulasies uitvaardig oor—
- (a) enige aangeleentheid wat kragtens hierdie Wet voorgeskryf moet of kan word; en
  - (b) enige aangeleentheid, oor die algemeen, wat nodig of wenslik is om voorgeskryf te word om die oogmerke van hierdie Wet te bereik.

#### **Wet bind Staat**

- 10    **13.** Hierdie Wet, behalwe artikel 9, bind die Staat.

#### **Herroeping van wette**

**14.** Die wette vermeld in die Bylae word hierby herroep in die mate in die derde kolom daarvan uiteengesit.

#### **Kort titel en inwerkingtreding**

- 15    **15.** Hierdie Wet heet die Wet op Pliglewering, 1997, en tree in werking op 'n datum deur die President by proklamasie in die *Staatskoerant* bepaal.
