NOTICE 353 OF 1998**INDEPENDENT BROADCASTING AUTHORITY****APPLICATION TO AMEND BROADCASTING LICENCES : SOUTH AFRICAN BROADCASTING CORPORATION (SABC)**

The Independent Broadcasting Authority gives notice, in accordance with section 52(2)(a) of the Independent Broadcasting Authority Act, Act 153 of 1993, that an application has been received in terms of section 52(1)(c) for amendments to the Public Sound Broadcasting Licences of the South African Broadcasting Corporation (SABC) as set out in the Schedule.

The Independent Broadcasting Authority recommended in its Triple Inquiry Report that the former TBVC territory broadcasters should be integrated into the SABC services. On 22 November 1997 the Minister for Posts, Telecommunications and Broadcasting published Notice 1813 of 1997 in Government Gazette No. 18454 to make provision for the incorporation of all the TBVC broadcasters into the SABC and Sentech (Pty) Ltd from 1 December 1997. The application for the amendment of the relevant SABC licences makes provision for the following:

1. **UMHLOBO WENENE FM**

The amendment to Umhlobo Wenene FM licence is for the addition of the network in the former Transkei Broadcasting Network utilised by Xhosa FM as set out in the schedule. The predicted coverage of the combined networks of the Isixhosa speaking population will be 83%.

2. **PHALAPHALA FM**

The amendment to Phalaphala FM licence is for the addition of the FM and AM network in the former Republic of Venda utilised by Radio Thohoyandou as set out in the schedule. The predicted coverage of the combined networks of the Tshvenda speaking population will be 94%.

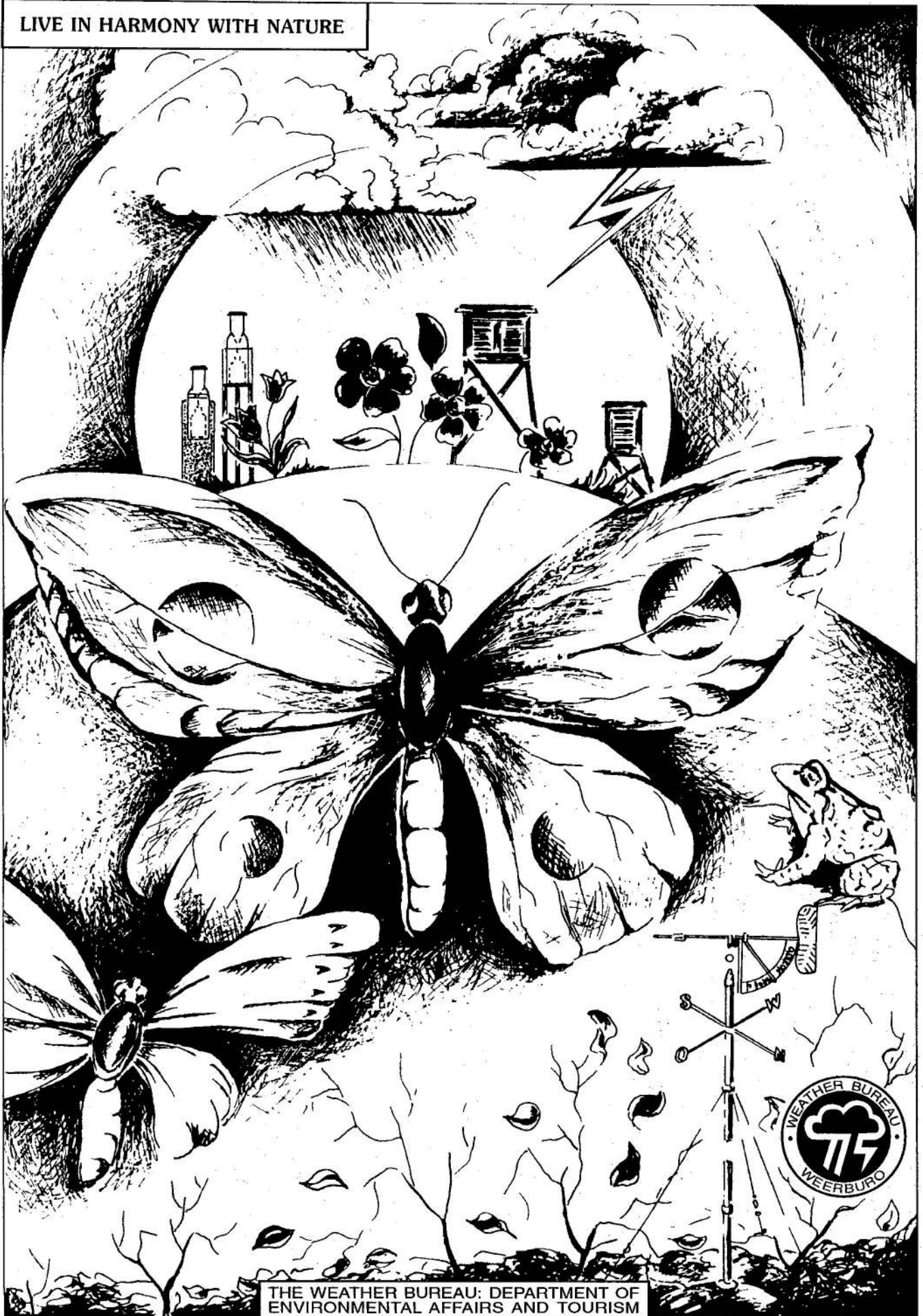
