**DECLARATION OF A MOVABLE CULTURAL TREASURE: THE SOUTH AFRICAN MINT COLLECTION,
HOUSED AT THE SOUTH AFRICAN MINT COMPANY (PROPRIETARY) LIMITED, CENTURION, PRETORIA**

In terms of section 5 (1) (cD) of the National Monuments Act, 1969 (Act No. 28 of 1969), the National Monuments Council hereby declares the South African Mint collection, as more fully described in the Schedule hereto, to be a national cultural treasure because of its historical and cultural importance.

SCHEDULE

The South African Mint collection which is presently housed at the South African Mint Company (Proprietary) Limited and consisting of the early Cape coins c1763, the ZAR coins, the South African coins, the Republic of South Africa coins, and the British, Cape, Orange Free State, South African, Republic of South Africa and ZAR patterns, as well as the Roman coins, the Southern Rhodesian coins, the South Korea coins, the Straits Settlement coins and all the other coins and patterns which were struck by the Mint as legal tender since its inception on 1 January 1923 in terms of the Pretoria Mint Act, No. 451 of 1919.

SPACE POLICY PAPER OF THE SOUTH AFRICAN COUNCIL FOR SPACE AFFAIRS (SACSA)

1. Introduction

The Republic is an established user of commercial space and space related technologies, and is in possession of such technologies and assets established by private and government enterprises.

As a signatory of the "Outer Space Treaty" of 1967 as well as other international treaties, the State accepts responsibility for all space activities in the Republic and undertakes to control and support such activities.

The State acknowledges that the application of commercial space and space-related technologies can create new opportunities for economic growth in the Republic. Furthermore, it can play an important role in keeping the Republic in pace with world trends with respect to high technology, which is important for future industrial growth.

The Space Affairs Act, 1993 (Act No. 84 of 1993), makes provisions for the establishment of a Council for its implementation and administration. The South African Space Council was established on 28 May 1997 and is funded by the Department of Trade and Industry.

2. Space Policy

2.1 With a view to meeting all the international commitments and responsibilities of the Republic of South Africa in respect of the peaceful utilization of outer space, in order to be recognized as a responsible and trustworthy user of outer space, the following policy is determined in terms of section 2 (1) (a) of the Space Affairs Act, 1993 (Act No. 84 of 1993), and is to be implemented by the South African Council for Space Affairs:

The South African Council for Space Affairs will—

- (a) advise the Minister on any matter that may have an influence on space affairs;
- (b) receive representations by any person regarding space affairs;
- (c) initiate, negotiate, coordinate, supervise and implement international conventions, treaties and agreements concerning space affairs to be entered into or ratified by the Government of the Republic;
- (d) issue licences under section 11 of the Space Affairs Act, 1993 (Act No. 84 of 1993) or amend, suspend or revoke them under section 13;
- (e) encourage persons and authorities involved in the space industry to register with the Council and to apply information regarding capabilities so obtained to enhance and co-ordinate the space industry and its capabilities;
- (f) subject to paragraph 2.3 of this document, designate knowledgeable persons from government institutions and the space industry as well as other experts as members of committees of the Council to assist the Council in the performance of its functions;
- (g) further matters leading to the orderly and responsible participation by any person or authority in space affairs;
- (h) subject to section 19 of the Space Affairs Act, 1993 (Act No. 84 of 1993), provide for the appropriate and widest possible publication of information concerning the activities of the Council;
- (i) subject to the provisions of this Act, perform any other activity with a view to contributing to the effective achievement of the objectives of the Council.

2.3 With a view to control and restrict the development, transfer, acquisition and disposal of dual purpose technologies, in terms of international conventions, treaties and agreements entered into or ratified by the Government of the Republic of South Africa, the policy is to be determined by the Minister of Trade and Industry in terms of section 2 (1) (b) of the Space Affairs Act, 1993 (Act No. 84 of 1993), upon consultation with the South African Council for Space Affairs and any other statutory body that may be determined by the Minister.

- 2.4 In terms of section 18 (1) and section 18 (2), subject to the provisions of section 18 (4) of the Act, the Minister and the Director-General of the Department of Trade and Industry may respectively delegate to the Chairperson of the Council their respective powers to appoint and dismiss any officials, employees inspectors, working groups and knowledgeable persons as he may deem necessary to ensure that the objectives of the Council are achieved.
