The Minister of Environmental Affairs and Tourism intends designating the site set out in the Schedule as a Wetland of International Importance for the List of Wetlands of International Importance as referred to in Article 2 of the Convention of Wetlands of International Importance Especially as Waterfowl Habitat.

Interested parties are requested to submit comments in connection with the proposed sites within 30 days from the date of publication of this notice. Comments must be submitted to the Acting Director-General: Environmental Affairs and Tourism, Private Bag X447, Pretoria, 0001.

## SCHEDULE

### 1. Nylsvley Nature Reserve Ramsar Proposal.

Nylsvley Nature Reserve is situated 12 km south of the Town of Naboomspruit in the Northern Province of the Republic of South Africa. The reserve forms part of a larger floodplain system extending from Middelfontein (west of Nylstroom) in the south-west to Moordrift (near Potgietersrus) in the north-east. The reserve is located in the upper reaches of the Nyl River floodplain. Nylsvley Nature Reserve comprises 3 970 ha whilst the floodplain/wetland area is approximately 500 ha. The geographical co-ordinates for Nylsvley Nature Reserve are 24° 39' S 28° 42' E. See Figure 1 (copy of 1:50 000 map)

To be proposed as a Ramsar site the wetland needs to comply with at least one of the 11 listed Ramsar criteria as adopted by the Conference of Parties. Nylsvley Nature Reserve qualifies to be listed because it complies with eight of the criteria as follows:

#### CRITERIA FOR WETLANDS:

##### Criteria 1 (a)

It is a particularly good representative example of a natural or near-natural wetland, characteristic of the appropriate biogeographical region.

##### Motivation

Nylsvley Nature Reserve forms part of the largest floodplain vlei in South Africa. It is well known for its exceptional avifaunal diversity. 102 waterfowl species have been recorded on this floodplain. The endangered Roan antelope (*Hippotragus equinus*) occur on this reserve.

The floodplain acts as a sink and is not flushed by floods as other hydrological systems are. On the other hand the floodplain (specifically permanently wet areas) is able to absorb and neutralize a certain level of pollution without adverse effects.

##### Criteria 1 (d)

It is an example of a specific type of wetland, rare or unusual in the appropriate biogeographical region.

##### Motivation

Nylsvley Nature Reserve forms part of the largest floodplain vlei in South Africa.

#### CRITERIA FOR PLANTS AND ANIMALS:

##### Criteria 2 (a)

It supports an appreciable assemblage of rare, vulnerable or endangered species or subspecies of plant or animal, or an appreciable number of individuals of any one or more of these species.

##### Motivation

Within the reserve eight South African Red Data listed waterfowl species have been recorded breeding. They are: Rufousbellied Heron (*Butroides rufiventris*), Little Bittern (*Ixobrychus minutus*), Dwarf Bittern (*Ixobrychus sturmii*), Bittern (*Botaurus stellaris*), Pygmy Goose (*Nettapus auritus*), Baillon's Crake (*Porzana pusilla*), Striped Crake (*Aenigmatolimnas marginalis*) and Black Stork (*Ciconia nigra*). In addition, this is the only site in South Africa where Rufousbellied Heron has been known to breed. The Striped Crake has not been recorded anywhere in the country besides on Nylsvley Nature Reserve.

Breeding of endangered Roan antelope which use the floodplain extensively is another of the conservation priorities for the reserve.

**Criteria 2 (b)**

It is of special value for maintaining the genetic and ecological diversity of a region because of the quality and peculiarities of its fauna and flora.

**Motivation**

Of particular interest are the stands of wild rice, *Oryza longistaminata*. The reserve and parts of the floodplain are the only recorded localities for this plant species in South Africa.

Breeding of endangered Roan antelope which use the floodplain extensively is another of the conservation priorities for the reserve.

**Criteria 2 (c)**

It is of special value as the habitat of plants or animals at a critical stage of their biological cycles (especially breeding conditions for waterfowl).

**Motivation**

During good rain seasons the floodplain becomes a hub of activity, the best estimate for water bird numbers on the floodplain in wet years is approximately 80 000. The floodplain also plays an important role for frogs which breed in their thousands after good rains. An influx of fish after a flood is often seen. It is estimated that 300 to 600 ton fish breeds on the floodplain, depending on the extent of the flood.

**Criteria 2 (d)**

It is of special value for its endemic plant or animal species or communities.

**Motivation**

Within the floodplain as a whole there is at least one rare and endemic (to old Transvaal) plant, *Ceropegia stentiae* (Asclepiadaceae).

**CRITERIA FOR WATERFOWL:****Criteria 3 (b)**

It regularly supports substantial numbers of individuals from particular groups of waterfowl, indicative of wetland values, productivity or diversity.

**Motivation**

During a good rain season the floodplain becomes a hub of activity, the best estimate for water bird numbers on the floodplain in wet years is approximately 80 000. This is the sum for the whole floodplain and was calculated as follows: 43 000 bitterns, crackles and rails, 12 000 egrets and herons (17 species), 19 000 ducks (17 species) plus the numbers of other groups such as cormorants, darters, spoonbills and storks.

**Criteria 3 (c)**

It regularly supports 1% of the individuals in a population of one species or subspecies of waterfowl.

**Motivation**

This is the only site in South Africa where Rufousbellied Heron has been known to breed. The floodplain also supports more than 1% of the populations of Great white egrets, Squacco herons, Blackheaded herons and Black crowned night herons in South Africa.

**BYLAE****1. Nylsvley Natuurreservaat Ramsar Voorstel.**

Nylsvley Natuurreservaat is 12 km suid van die dorp Naboomspruit in die Noordelike Provinsie in die Republiek van Suid-Afrika geleë. Die reservaat vorm deel van 'n groter vloedvlaktesisteem en dit strek vanaf Middelfontein (wes van Nylstroom) in die suidweste tot by Moordrift (naby Potgietersrus) in die noordooste. Nylsvley Natuurreservaat beslaan 3 970 ha terwyl die vloedvlakte/vleilandgebied ongeveer 500 ha hiervan uitmaak. Die geografiese koördinate vir Nylsvley Natuurreservaat is 24° 39' S 28° 42' O. Om as 'n Ramsargebied voorgestel te word moet die vleiland ten minste aan een van die elf gelyste Ramsar-kriteria soos aanvaar deur die Konferensie van Partye, voldoen. Nylsvley Natuurreservaat kwalificeer om gelys te word aangesien dit aan agt van die kriteria voldoen naamlik:

**KRITERIA VIR VLEILANDE:****Kriterium 1 (a)**

Dit is 'n besondere goeie verteenwoordigende voorbeeld van 'n natuurlike of amper natuurlike vleiland, eie aan die spesifieke biogeografiese streek.

**Motivering**

Nylsvley Natuurreservaat maak deel uit van die grootste vloedvlaktevlei in Suid-Afrika. Dit is goed bekend vir die uitsonderlike voëlverskeidenheid. 102 watervoëlspesies is op die vloedvlakte aangeteken. Die bedreigde bastergemsbok (*Hippotragus equinus*) kom ook op die reservaat voor.

**Kriterium 1 (d)**

Dit is 'n voorbeeld van 'n spesifieke tipe vleiland, skaars of ongewoon in 'n spesifieke biogeografiese streek.

**Motivering**

Nylsvley Natuurreservaat maak deel uit van die grootste vloedvlaktevlei in Suid-Afrika.

**KRITERIA VIR PLANTE EN DIERE:****Kriterium 2 (a)**

Dit onderhou 'n noemenswaardige versameling skaars, kwesbare of bedreigde spesies of subspesies van 'n plant of dier, of 'n noemenswaardige aantal individue van een of meer van hierdie spesies.

**Motivering**

Dit is aangeteken dat agt Suid-Afrikaanse Rooidatalys-watervoëlspesies al in die reservaat gebroei het. Hulle is die Rooipensreier (*Butorides rufiventris*), Kleinrietreier (*Ixobrychus minutus*), Dwergrietreier (*Ixobrychus sturmii*), Grootrietreier (*Botaurus stellaris*), Dwerggans (*Nettapus auritus*), Kleinriethaan (*Porzana pusilla*), Gestreepte Riethaan (*Aenigmatolimnas marginalis*) en Grootwartooievaar (*Ciconia nigra*). Dit is ook die enigste plek bekend in Suid-Afrika waar die Rooipensreier broei. Nylsvley Natuurreservaat is ook die enigste plek in Suid-Afrika waar die Gestreepte Riethaan aangeteken is.

Die teëling van die bedreigde bastergemsbok wat die vloedvlakte ekstensief gebruik is ook een van die bewaringsprioriteite van die reservaat.

**Kriterium 2 (b)**

Dit is van spesiale belang vir die instandhouding van die genetiese en ekologiese verskeidenheid van 'n streek, as gevolg van die kwaliteit en eienaardighede van die fauna en flora.

**Motivering**

Van besondere belang is die plate wilde rys, *Oryza longistaminata*. Die reservaat en dele van die vloedvlakte is die enigste aangetekende lokaliteite vir die plantspesie in Suid-Afrika.

Die teëling van die bedreigde bastergemsbok wat die vloedvlakte ekstensief gebruik, is ook een van die bewaringsprioriteite van die reservaat.

**Kriterium 2 (c)**

Dit is van spesiale waarde as habitat vir plante of diere tydens 'n kritieke stadium van hul biologiese siklus (veral die broei-omstandighede van watervoëls).

**Motivering**

Gedurende 'n goeie reënjaar wemel die vloedvlakte van aktiwiteite, die beste beraming vir voëlgetalle op die vloedvlakte gedurende 'n nat jaar is ongeveer 80 000 voëls. Die vloedvlakte speel ook 'n belangrike rol vir paddas wat in hul duisende voorkom na goeie reën. 'n Instroming van vis word gereeld ook na goeie reën waargeneem. Dit word geskat dat 300 tot 600 ton vis op die vloedvlakte broei, afhangende van die omvang van die vloed.

**Kriterium 2 (d)**

Dit is van spesiale waarde vir die endemiese plante en diere spesies of gemeenskappe.

**Motivering**

Daar kom ten minste een skaars en endemiese (aan die ou Transvaalstreek) plantspesie op die vloedvlakte voor, *Ceropegia stentiae* (Asclepiadaceae).

**KRITERIA VIR WATERVOËLS:****Kriterium 3 (b)**

Dit onderhou gereeld groot getalle individue van 'n spesifieke groep watervoëls, as aanduiding van vleilandwaarde, produktiwiteit of verskeidenheid.

**Motivering**



Under section 2 (1) (c) and 2 (3) of the Provision of Certain Land for Settlement Act, 1993 (Act No. 126 of 1993), read with President's Minute No. 13 of 10 June 1994, I, Derek André Hanekom, Minister of Land Affairs, hereby designate—

**Subdivision 2 of the farm Vaalspruit 115,**

situated in the District of Utrecht, Province of KwaZulu-Natal, for the purposes of settlement and hereby impose the following conditions for the use of the designated land:

- (i) The **Menziwa Farmers and Stockowners Trust** (Registration No. IT 1496/95) (hereinafter referred to as the Trust) must hold the land for the benefit of 28 identified families.
- (ii) No settlement may take place before a development plan has been submitted to me for approval and such planning has been done: Provided that should it be necessary that settlement must take place before the development planning has been done, application may be made to the Director-General: Land Affairs, who may identify the settlement area in collaboration with the Trust and the Provincial Government.

- (iii) The Trust must ensure that the provisions of the Water Act, 1956 (Act No. 54 of 1956), and the Conservation of Agricultural Resources Act, 1983 (Act No. 43 of 1983), are complied with.
- (iv) The Trust must ensure that the carrying capacity of the land is not exceeded.
- (v) The Provincial Minister of Local Government and Housing may in terms of legislation at his or her disposal establish an appropriate local government body to manage and administer conditions of planning, development and local government administration of the land.

**NOTICE 605 OF 1998****SOUTH AFRICAN LAW COMMISSION****INVESTIGATION INTO THE JURISDICTION OF MAGISTRATES' COURTS IN CONSTITUTIONAL MATTERS  
(PROJECT 111): DISCUSSION PAPER 75**

The South African Law Commission has published its Discussion Paper 75 on the *Jurisdiction of Magistrates' Courts in Constitutional Matters* for general information and comment. On 22 May 1997, the Minister of Justice asked the Law Commission to include in its programme for investigation the need for remedial legislative proposals, which are not in conflict with the other provisions of the Constitution, providing for appropriate instances where Magistrates' Courts should have jurisdiction in constitutional matters. On 8 December 1997, the Commission received from the Minister of Justice a request that its investigation commissioned earlier by him be widened. Commissioner J. J. Gauntlett, SC, was asked by the Commission to undertake the investigation on its behalf. It arises in the following circumstances:

- Section 103 (2) of the Constitution of the Republic of South Africa Act, 1993 ("the interim Constitution"), provided that—
  - if in any proceedings before a court referred to in subsection (1), it is alleged that any law or provision of such law is invalid on the ground of its inconsistency with a provision of this Constitution and the court does not have the competency to inquire into the validity of such a law or provision, the court shall subject to the other provisions of this section, decide the matter on the assumption that the law or provision is valid.
- No similar provision is to be found in the Constitution of the Republic of South Africa Act, 1996. Section 170 of the Constitution provides as follows:
  - magistrates' courts and all other courts may decide any matter determined by an Act of Parliament, but a court of a status lower than a High Court may not inquire into or rule on the constitutionality of any legislation or any conduct of the President.

It would seem that the main inquiries which arise in this investigation, are these:

- (a) Do Magistrates' Courts at present have any jurisdiction of a constitutional nature under the Constitution, and if so, to what extent?
- (b) Is it desirable that Magistrates' Courts have jurisdiction in respect of constitutional matters, and if so, to what extent?
- (c) If it is considered that Magistrates' Courts lack jurisdiction in respect of constitutional matters, how is the situation to be remedied?
- (d) Is it desirable that Magistrates' Courts retain their current jurisdiction in terms of section 110 of the Magistrates' Courts Act, 1944 in relation to what its heading describes as a "plea of ultra vires"?

The following preliminary recommendations are made in the Discussion Paper:

- It is suggested that magistrates' courts should be given a constitutional jurisdiction appropriate to their position in the court structure in South Africa. They represent the primary means of access to justice for most South Africans. An exclusion of all constitutional jurisdiction would be inappropriate, more particularly in view of the interactive growth between the common law and our developing constitutional law contemplated by section 8 (3) of the Constitution.
- If this approach is supported, the extent of an appropriate constitutional jurisdiction arises. It is proposed that this include not only the general or "common law" aspects, but the legislative areas long encompassed by section 110 of the Magistrates' Court Act.
- It is proposed that the existing *ultra vires* jurisdiction of section 110 of the Magistrates' Court Act be retained.
- It is proposed that sections 170 and 172 of the Constitution and section 110 of the Magistrates' Court Act (and the relevant Rules) be amended to provide—
  - > in section 72 of the Constitution that Magistrates' Courts and all other courts may decide any matter determined by an Act of Parliament, but a court of a status lower than a High Court may not rule on the constitutional validity of any Act of Parliament, any legislation passed by the legislature of a province after 27 April 1994, or any conduct of the President;

> in section 172 of the Constitution that—

- the Full Bench of a High Court of competent jurisdiction must confirm any order of constitutional invalidity made by a Magistrates' Court or another court of a status lower than a High Court, before that order has any force;
- subsections 2 (b), (c) and (d) of section 172 apply with the necessary changes to an order of constitutional invalidity made by a Magistrates' Court or another court of a status lower than a High Court, and to any referral of, appeal against, or application for the confirmation of, such order, to the Full Bench of a High Court of competent jurisdiction;

> in section 110 of the Magistrates' Courts Act, 1944 that—

- no magistrate's court shall be competent to rule on the constitutional validity or validity for any other reason of any Act of Parliament, any legislation passed by the legislature of a province after 27 April 1994, or any conduct of the President, and every magistrate's court shall assume that any such Act, legislation or conduct is valid;
- subject to subsection (1), every magistrate's court shall be competent to rule on the constitutional validity or for any other reason of—
  - (a) any administrative action, including any executive action and any statutory proclamation, regulation, order, by-law or other legislation; but no magistrate's court shall review and set aside or correct any administrative action or make any order directing an organ of state to legislate, decide or correct defects in any administrative action or in any state of affairs resulting from administrative action; and
  - (b) any rule of the common law, customary law and customary international law".

The issues mentioned above and other options for the improvement of the law need to be debated thoroughly. Based on the outcome a report containing the Commission's final recommendations and legislation in respect of the constitutional jurisdiction of Magistrates' Courts will be prepared and presented to the Minister of Justice. The comments of all parties who feel that they have an interest in this topic or who may be affected by the type of measures discussed in this paper are therefore of vital importance to the Commission. All respondents are invited to indicate whether there are any other issues and/or options that they feel should be explored. **All interested parties likely to be affected by possible legislation should participate in this debate.**


