CALL FOR COMMENTS ON THE GREEN PAPER FOR FURTHER EDUCATION AND TRAINING (FET)

The National Committee on Further Education (NCFE) handed its report to me during the second half of 1997. The report provides a framework for the transformation of further education and training. Comments on the NCFE report were requested through advertisements in newspapers and also through *Government Gazette* No. 18546 of 19 December 1997.
