## APPLICATIONS FOR PUBLIC ROAD CARRIER PERMITS

Particulars in respect of applications for public road carrier permits (as submitted to the respective local road transportation boards or the National Transport Commission) indicating, firstly, the reference number, and then—

- (a) the name of the applicant;
- (b) the place where the applicant conducts his business or wishes to conduct his business, as well as his postal address;
- (c) the nature of the application, that is whether it is an application for—
  - (C1) the grant of such permit,

  - (C5) the amendment of tariffs,

  - (C7) the transfer of such permit,

  - (C9) the replacement of a vehicle,
  - (C10) the amendment of vehicle particulars; or

(C11) an additional vehicle with existing authorisation;

—as well as, in the case of an application contemplated in (C6) or (C7)—

(C12) the number of the permit concerned;

- (d) the number and type of vehicles, including the carrying capacity or gross vehicle mass of the vehicles involved in the application;
- (e) the nature of the road transportation or proposed road transportation, that is whether it involves persons or goods, or both;
- (f) the class or classes of goods that are conveyed or are to be conveyed; and
- (g) the points between or the route or routes along or the area or areas within which the road transportation is conducted or the proposed road transportation is to be conducted,

where any of (a) to (g) are applicable, are published below in terms of section 14(1) of the Road Transportation Act, 1977 (Act No 74 of 1977).

In terms of regulation 4 of the Road Transportation Regulations, 1977, written representations supporting or opposing these applications must, within 21 (twenty-one) days from the date of this publication, be lodged by hand with, or dispatched by registered post to, the local road transportation board concerned in quadruplicate, and lodged by hand with, or dispatched by registered post to, the applicant at his advertised address (see (b)) in single copy.

Charge a minimum of R1,80 per parcel/piece, in respect of all pieces of excessive hand luggage conveyed inside the bus or on the roof, or in trailer attached to the bus, where applicable or as per agreement. 5. Deviate from any authorised route: (a) When forced to do so by any fortuitous or temporary blockage or obstruction on the said route, preventing the use thereon, or any portion thereof, of the vehicle to which this permit relates, or by the existence on that route or any portion thereof of conditions which would render such use dangerous to the vehicle or to any passengers being conveyed thereon. *Subject to the condition that:* (i) The most practicable and accessible route to be followed. (ii) In the event of the deviation coinciding with the route of a competitive operator, steps be taken to reduce any adverse effect on such operation. (iii) The issuing authority be notified in writing within 24 hours of such deviation or on the first subsequent working day. 6. Convey own spare parts for own use, only when required for the bona fide repair and/or maintenance of own vehicles which have become defective and have to be expeditiously and urgently repaired within the RSA. 7. To charge a tariff "as per agreement" for the transport of passengers on an existing route or portion of an existing route when a contract has been entered into between Nkomazi Transport (Pty) Ltd and another bus for the hire of the vehicle mentioned in this permit. 8. To convey post bags on behalf of Telkom or any of its affiliates or agents on all authorised routes — tariff "as per agreement". 9. To be allowed not to complete any specific route/routes when circumstances warrants, but to render a service just on part of that route/routes. 10. In respect of seasonal workers, to adapt time tables and when required by their employers, according to the need of the workers. 11. The holder will not be compelled to operate a trip if no passengers are available. 12. Parts of the route or the whole route can be served as and when required. 13. Where a town or residential area are properly described on a route operated that the nearest or closest off-ramp as determined by the local authority will be followed to such a town or residential area. 14. The holder shall be entitled to co-ordinate and to join trips on all routes. *Organised groups:* Persons who have organised themselves in a group and their effects from places and points situated within a radius of 10 (ten) kilometres from any

route served by the holder in terms of this permits, to places situated within an area with a radius of 500 (five hundred) kilometres from Malelane Post Office and return to the original places of departure for the sole purpose of attending one or more of the following: (a) a wedding; (b) a funeral; (c) a religious gathering; (d) an educational meeting; (e) a sports meeting, either as participants or spectators; (f) a picnic or other form of organised recreation.
