DEPARTMENT OF ENVIRONMENTAL AFFAIRS AND TOURISM

INVITATION TO SUBMIT NOMINATIONS FOR THE CONSULTATIVE ADVISORY FORUM FOR MARINE LIVING RESOURCES

It is the intention of the Minister of Environmental Affairs and Tourism to establish the Consultative Advisory Forum for Marine Living Resources (the Forum) in terms of section 5 of the Marine Living Resources Act, 1998 (Act No. 18 of 1998) and to appoint its members in accordance with the provisions of section 7 of that Act.

The Forum will advise the Minister of Environmental Affairs and Tourism on any matter referred to it by him or her, and in particular on the management and development of the fishing industry, including issues relating to the total allowable catch; marine living resources management and related legislation; the establishment and amendment of operational

management procedures, including management plans; recommendations and directives on areas of research, including multi-disciplinary research; and the allocation of money from the Marine Living Resources Fund.

Any interested person, for example from a rural, urban or coastal community, the fishing industry, subsistence or artisanal fishing, organised labour, a small or medium-size enterprise, a fish processing establishment, a mariculture venture, a rural, urban or coastal organisation, a non-governmental organisation, the scientific or research corps, an environmental conservation group, recreational fishing or a concerned individual, is invited to nominate suitable persons or to make himself or herself available to serve on the Forum.

In accordance with the provisions of the Act the Minister shall ensure that the Forum be broadly representative and multidisciplinary, with members qualified to make a substantial contribution towards the proper functioning of the Forum.

NB: Appointment to the Forum is viewed as a service to the community and no financial compensation is payable. Expenses incurred will, however, be compensated.

Each nomination must contain a motivation, a curriculum vitae and the names, addresses and telephone numbers of two persons supporting the nomination. TRANSFORMATION COUNCIL**

It is the intention of the Minister of Environmental Affairs and Tourism to establish the Fisheries Transformation Council (the Council) in terms of section 29 of the Marine Living Resources Act, 1998 (Act No. 18 of 1998) and to appoint its members in accordance with the provisions of section 34 of that Act.

The main object of the Council shall be to facilitate the achievement of fair and equitable access to rights to undertake commercial fishing or subsistence fishing, or to engage in mariculture or to operate a fish processing establishment. The Council shall lease rights received from the Minister according to criteria determined by the Minister, to persons from historically disadvantaged sectors of society and to small and medium size enterprises and assist them in their development and capacity building.

Interested persons are invited to nominate suitable persons or to make themselves available to serve on the Council.

In accordance with the provisions of the Act the Minister shall ensure that the Council be broadly representative and multidisciplinary, with members qualified to make a substantial contribution towards the proper functioning of the Council.

NB: No person who has a direct interest in any manner whatsoever in commercial fishing or mariculture may be appointed to the Council.

NB: Financial compensation is payable to a member of the Council who is not in the full-time employment of an organ of state.

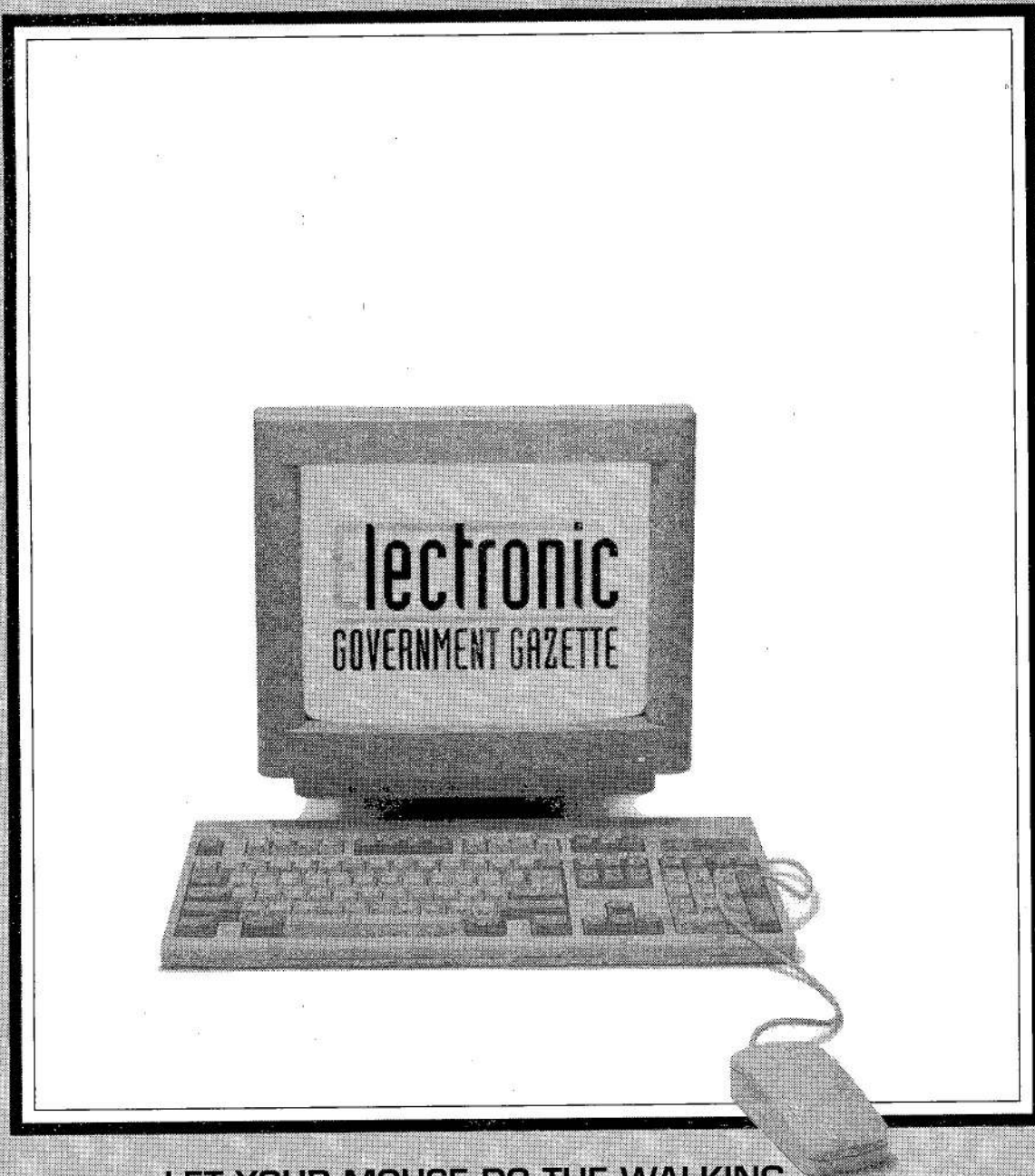
