1. **Badminton South Africa (H4/3/1/1444)**

Badge: On a background Sable, within an open laurel wreath Argent, a *Protea Cynaroides* slipped and leaved proper, voided of the field, charged with a shuttlecock Or.

Name: Badminton South Africa

2. Wildlife and Environment Society of South Africa (H4/3/1/2350)

Badge: A fillet annulet Sable, surmounted by the head and neck of a sable antelope contourné proper.

3. South African Institute for Environment Health (H4/3/1/3853)

Arms: Argent, between flanches Vert, a staff also Vert entwined of two cobras respectant Azure, langued Gules, ensigned with a protea Gules, seeded Argent, slipped and leaved Vert.

Crest: An ankh Azure, within an open wreath of protea flowers Gules, seeded Argent and leaved Vert.

Wreath and mantling: Vert and Argent.

Supporters: Two secretary birds proper, each charged on the breast with an ankh Azure.

Motto: CUSTOS SALUTIS PUBLICAE

4. Distillers Corporation (H4/3/1/3859)

Arms: Per pile embowed inverted throughout, Gules, Sable and Azure, fimbriated Argent, dexter three wine pitchers Argent, 2 and 1, sinister a bull's head caboshed Or, armed Argent, and in base a windmill Or, sails Argent and door Gules; a base wavy, per fess wavy, Argent and Sable.

Crest: Issuant from a coronet consisting of a circlet heightened with four fleurs-de-lis Or, alternating with as many pearls, a vol Argent ensigned of a bull's head caboshed Sable, armed Or.

Wreath and mantling: Gules and Argent.

Motto: ORA ET LABORA

5. Mondoro Safaris (H4/3/1/3864)

Badge: Two sable antelope heads coupé and addorsed proper, surmounted of a Nguni shield Argent, charged with two chevrons coupé, between in chief and in base four shield thongs respectively, Sable; behind the shield two spears in saltire, of the last.

6. Uplands College (H4/3/1/3866)

Arms: Per chevron inverted Gules and Vert, a pall Azure, fimbriated Or, surmounted at honour point by a latin cross flory Or.

7. Kameelfontein Primary School (H4/3/1/3868)

Arms: Or, six vertically coupé piles embowed in point, 3 and 3, in chief a triquetra, Azure.

Motto: REIK HOOG.

8. South African Police Service Air Wing (H4/3/3/10/5)

Badge: The badge of the South African Police Service as described in Government Notice No. 1548 of 6 October 1995, between wings issuant fesswise, Or.

9. Council of Traditional Leaders (H4/3/3/102)

Arms: Argent, six bars coupé Sable, the shield ensigned of a lion statant gardant proper; behind the shield a knobkierie and a spear in saltire, proper.

Supporters: Two leopards proper.

Motto: UNITY IN DIVERSITY

10. Peter Gowar Joubert (H4/3/4/568)

Arms: Azure, a pair of wings elevated and conjoined Argent, between in chief a barrulet of the second surmounted by three bezants and in base a pair of keys in saltire, Or.

Crest: Issuant from a crest coronet of four fleurs-de-lis Or, embellished with as many pearls, a mount Gules, thereupon a pegasus passant Azure winged Or, unguled Argent, gorged of a similar coronet and chained Or, supporting with its dexter forehoof a Maltese cross, Argent.

Wreath and mantling: Azure and Argent.

Motto: ADDE AESTIMATIONEM

11. Gerhard Max Völger (H4/3/4/582)

Arms: Per fess Or and Gules, in chief a peregrine falcon displayed with wings inverted proper, holding its beak an annulet Sable, and in base on a bend sinister reduced Or, three wheels Sable.

Wreath and mantling: Gules and Or.

Motto: DREAD GOD

Naam: Badminton South Africa
2. **Wildlife and Environment Society of South Africa (H4/3/1/2350)**
Kenteken: 'n Swart streepring, daaroorheen die omgewende kop en hals van 'n swartwitpens van natuurlike kleur.
3. **South African Institute for Environment Health (H4/3/1/3853)**

9. **Raad van Tradisionele Leiers (H4/3/3/102)**
Wapen: In silwer, ses swart verkorte dwarsbalke; die skild oortop van 'n staande aansiene leeu van natuurlike kleur; skuinsgekruis agter die skild 'n knopkierie en 'n spies, albei van natuurlike kleur.
Skildhouers: Twee luiperds van natuurlike kleur.
Wapenspreuk: UNITY IN DIVERSITY

NOTICE OF THE URGENT INVESTIGATION OF A PROPOSAL TO INCREASE THE FINAL ANTI-DUMPING DUTY IMPOSED ON ALUMINIUM HOLLOWWARE IMPORTED FROM EGYPT AND MANUFACTURED BY ANY MANUFACTURER OTHER THAN ATLAS ALUMINIUM FACTORY AND SALLY ALUMINIUM INDUSTRIES

The Board on Tariffs and Trade hereby gives notice of its urgent investigation of a proposal to increase the anti-dumping duties published in *Government Gazette* No. 17779, Notice No. 234 on 7 February 1997, relating to aluminium hollowware imported from Egypt and manufactured by any manufacturer other than Atlas Aluminium Factory and Sally Aluminium Industries. It is proposed that the duty imposed in terms of Board Report No. 3727 will be increased from R 2,52/kg to R 29,53/kg.

REASONS FOR PROPOSED INCREASE

During the initial anti-dumping investigation and in response to representations by the Egyptian Government, the Board decided to impose a residual anti-dumping duty of R 2,52/kg on hollowware imported from Egypt manufactured by any manufacturer other than Atlas Aluminium Factory and Sally Aluminium Industries, based on the weighted average export price of the other Egyptian exporters to South Africa (excluding the two exporters in respect of which individual dumping duties were calculated). In response to specific representations by the Egyptian Government on this issue and the request that the Board consider Article 15 of the Anti-Dumping Agreement, the Board decided not to impose the highest anti-dumping duty on the other exporters, in accordance with its usual policy.

However, information in possession of the Board on Tariffs and Trade indicates that the anti-dumping duties which were imposed on the specific manufacturers are being circumvented by certain exporters and/or importers through this lower residual duty. It is therefore proposed that the Board increase the final anti-dumping duty on aluminium hollowware imported from Egypt and manufactured by any manufacturer other than Atlas Aluminium Factory and Sally Aluminium Industries from R 2.52 / kg to R 29.53 / kg.

The Trade Representative of Egypt has been notified of the investigation of the proposal. Importers, exporters and interested parties are invited to contact the Board as soon as possible in order to respond to this proposal. Any representations must be made, within the time limit set out below.

BOARD ON TARIFFS AND TRADE**NOTICE OF INITIATION OF AN INVESTIGATION INTO THE ALLEGED DUMPING OF STAINLESS STEEL SINKS, ORIGINATING IN OR IMPORTED FROM EGYPT, MALAYSIA AND SOUTH KOREA**

The Board on Tariffs and Trade received a petition alleging that stainless steel sinks, originating in and/or imported from Egypt, Malaysia and South Korea are being dumped on the Southern African Customs Union (SACU) market, causing material injury (and threat of material injury) to the SACU industry concerned.

The petitioner

The petition was lodged by City Metal Products(Pty) Ltd, supported by Southern Africa Stainless Steel Development Association (SASDA) and Pabar. The petitioner alleged that it cannot compete with the low prices charged by the importer and that the allegedly dumped imports are causing it material injury. The petitioner submitted sufficient evidence and established a prima facie case to enable the Board to arrive at a reasonable conclusion that an investigation should be initiated on the basis of dumping, material injury and causality.

The product

The product allegedly being dumped (the subject product) is stainless steel sinks, classifiable under tariff subheading 7324.10, originating in or imported from Egypt, Malaysia and South Korea.

The allegation of dumping

The allegation of dumping is based on the comparison between the normal values in the respective countries, being the highest export price to a third country as contemplated in paragraph of 1 (1) (b) (i) the Board on Tariffs and Trade Act 1986, and

the export prices from the respective countries. The petitioner provided sufficient evidence to show that the subject product is being dumped into the SACU market from Egypt, Malaysia and South Korea.

The allegation of material injury/threat of material injury and causal link

The petitioner alleged and submitted sufficient evidence to show that the allegedly dumped imports are suppressing and depressing its selling prices, and are gaining market share at the expense of the SACU industry. It further alleged and provided evidence that the prices at which these imports are sold in South Africa undercut the already suppressed prices of the South African producers, resulting in lower profit margins being incurred by the petitioner. It also alleged and provided evidence that it had experienced a loss in its sales volume and revenue, its production volume, as well as a decrease in its production capacity utilisation rate over its last financial year. On this basis the Board found that there was prima facie proof of material injury and/or threat of material injury and causal link.

Period of investigation

The period of investigation for the purpose of determining the dumping margins in the respective countries of origin will be from 1 June 1997 to 31 May 1998. The period of investigation for purposes of determining injury will be from January 1995 to April 1998. If there are subsequent events that are relevant to injury the Board may later request and consider further, more recent information in determining injury.

Procedural framework

Having decided that there is sufficient evidence and a prima facie case to justify the initiation of an investigation, the Board has begun an investigation in terms of section 4 of the Board on Tariffs and Trade Act, 1986 (the BTT Act). The Board will conduct its investigation in accordance with the BTT Act and the World Trade Organisation Agreement on Implementation of Article VI of the GATT 1994 (the Anti-Dumping Agreement). A copy of the Anti-Dumping Agreement is available from the Board's office on request.

In order to obtain the information it deems necessary for its investigation, the Board will send questionnaires to all known importers and exporters, and known representative associations. The trade representatives of the exporting countries have been notified. Importers, exporters and other interested parties are invited to contact the Board as soon as possible in order to determine whether they have been listed and sent a questionnaire. If not, they should request a copy of the questionnaire as soon as possible. The questionnaire must be completed, and any other representations made, within the time limit set out below.

Definition

1. In this Schedule "the Regulations" means the Regulations published by Government Notice No. R. 797 of 2 April 1990, as amended by Government Notice No. R. 1597 of 28 June 1991, Government Notice No. R. 2070 of 16 August 1991, Board Notice 84 of 6 August 1993 and Board Notice 11 of 3 February 1995.

Substitution of regulation 9 of the Regulations

2. The following regulation is hereby substituted for regulation 9 of the Regulations:

"9. (1) In this regulation, unless the context otherwise indicates—

"security business" means a company, close corporation, sole proprietor, partnership or business trust.

- (2) The fees payable in terms of these regulations shall be as follows:
- (a) Registration fee
 - (i) Every application for registration as a security officer by a security business for the purposes of regulation 2: **R2 000,00** (excluding VAT).
 - (ii) Application for registration as a security officer not falling under paragraph (i): **R35,00** (excluding VAT).
 - (b) Annual fees
 - (i) Payment of annual fees for the purposes of regulation 7 (1) by a security business, registered as a security officer and that uses or provides one or more security officers to render a security service: **R2 400,00** (excluding VAT).
 - (ii) Payment of annual fees by security officers not falling under paragraph (i): **R84,00** (excluding VAT).
- (3) This regulation shall come into operation on **1 October 1998**."

as lid van die Raad vir die ampstermyn van die dag na die 1998 Algemene Jaarvergadering tot die einde van die 1999 Algemene Jaarvergadering.

Die skriftelike aanvaarding deur die genomineerde persoon, moet bogenoemde nominasies vergesel en moet die Direkteur bereik minstens vyf weke voor die datum bepaal vir die Algemene Jaarvergadering, en nie later nie as 25 September 1998. Alle genomineerde persone moet ingevolge Reël 7.1, gelees met artikel 57 van die Wet op Prokureurs, praktiserende prokureurs en lede van die Wetsgenootskap wees.
