Act No. 42, 1998 SOUTH AFRICAN PASSPORTS AND TRAVEL DOCUMENTS AMENDMENT ACT, 1998

GENERAL EXPLANATORY NOTE:

ACT

To amend the South African Passports and Travel Documents Act, 1994, so as to further regulate the power of the Minister to make regulations; and to provide for matters connected therewith.

BE IT ENACTED by the Parliament of the Republic of South Africa, as follows:—

Amendment of section 4 of Act 4 of 1994

1. Section 4 of the South African Passports and Travel Documents Act, 1994, is hereby amended by the deletion in paragraph (a) of subsection (1) of the word “and” at the end of subparagraph (ii), the addition of the word “and” at the end of subparagraph (iii) and the addition of the following subparagraph to the said paragraph: 5

“(iv) the taking of fingerprints;”.

Short title and commencement

2. This Act is called the South African Passports and Travel Documents Amendment Act, 1998, and shall be deemed to have taken effect on 13 July 1994. 10

“(iv) die neem van vingerafdrukke;”.
