N'KOMAZI MAJOR IRRIGATION DISTRICT, DISTRICT OF BARBERTON, MPUMALANGA PROVINCE: ESTABLISHMENT IN TERMS OF SECTION 73 OF THE WATER ACT, 1956

By virtue of powers vested in me by section 73 of the Water Act, 1956 (Act No. 54 of 1956), I, Kader Asmal, in my capacity as Minister of Water Affairs and Forestry, hereby declare the areas described in Proclamation No. 132 of 11 June 1971, Proclamation No. 285 of 20 October 1969 and Proclamation No. 334 of 30 December 1949 to be an irrigation district, which shall be known as the N'komazi Major Irrigation District.
