DECLARATION OF PROPERTY TO BE A NATIONAL MONUMENT

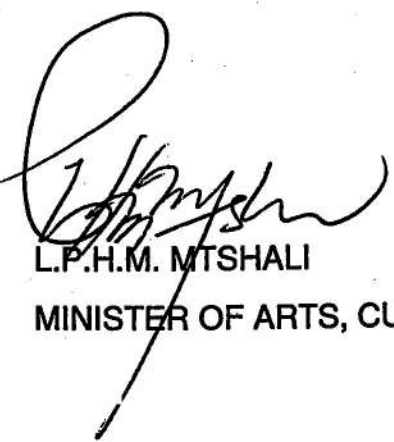
By virtue of the powers vested in me by section 10(1) of the National Monuments Act, 1969 (Act No. 28 of 1969), I, Lionel Percival Hercules Mbeki Mtshali, Minister of Arts, Culture, Science and Technology, hereby declare the property as fully described in the Schedule hereto to be a national monument.

SCHEDULE

1. THE SITE OF THE AEROPLANE ACCIDENT IN WHICH PRESIDENT SAMORA MACHEL DIED, NEAR THE MBUZINI SETTLEMENT, BARBERTON DISTRICT, PROVINCE OF MPUMALANGA

Description

The site which marks the approximate area of the aeroplane accident on 19 October 1986, in which President Samora Machel of Mozambique and 34 of his compatriots and travelling companions died, situated near the Mbuzini settlement in the Barberton District, Province of Mpumalanga, on unregistered State Land, in extent 629 (six hundred and twenty-nine) square metres, as indicated by the figure ABCD on Surveyor's Diagram SG No. 8344/1998, dated 23 July 1998, and filed in the office of the Surveyor-General in Pretoria and on file 9/2/203/21 in the office of the National Monuments Council in Cape Town.

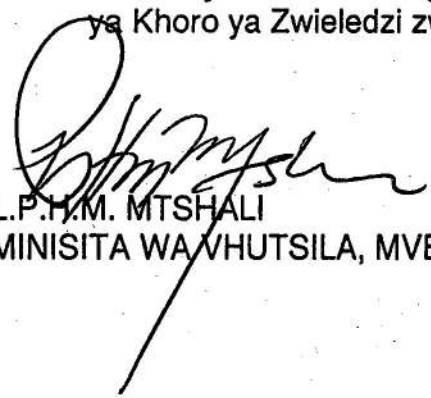
