DESIGNATION OF CERTAIN LAND SITUATED IN THE DISTRICT OF BRONKHORSTSPRUIT, PROVINCE OF GAUTENG

Under sections 2 (1) (c) and 2 (3) of the Provision of Land and Assistance Act, 1993 (Act No. 126 of 1993), I, Derek André Hanekom, Minister of Land Affairs, hereby designate—

Holdings 22, 23, 24, 25, 26 and 27 of Cilvale Agricultural Holdings JR,

situated in the District of Bronkhorstspuit, Province of Gauteng, for the purposes of settlement and hereby impose the following conditions for the use of the designated land:

- (i) The Tembisa Farmers' Trust (hereinafter referred to as the Trust) to be established and registered in terms of the Trust Property Control Act, 1988 (Act No. 57 of 1988), must hold the land for the benefit of 17 identified families.
- (ii) No settlement may take place before a development plan has been submitted to me for approval and such planning has been done: Provided that should it be necessary that settlement must take place before the planning for development and actual development has been done, application may be made to the Director-General of the Department of Land Affairs, who may identify the settlement area in collaboration with the Trust and the Eastern Gauteng Services Council (EGSC), in conjunction with the Bronberg Transitional Rural Council.
- (iii) The Trust must ensure that the provisions of the Water Act, 1956 (Act No. 54 of 1956), and the Conservation of Agricultural Resources Act, 1983 (Act No. 43 of 1983), are complied with and that no live stock is kept permanently within the residential area. Suitable camps shall be created and maintained in the identified area where it has been agreed that livestock is kept.
- (iv) The level of services infrastructure to be constructed shall be determined by the EGSC and the Bronberg TRC in consultation with the Trust taking financial constraints into account.
- (v) The EGSC and Bronberg TRC in consultation with the Trust shall determine appropriate conditions for settlement, taking into account—
 - relevant provincial planning laws and regulations;
 - the National Building Regulations and Building Standards Act, 1977 (Act No. 103 of 1977); and
 - relevant municipal laws.

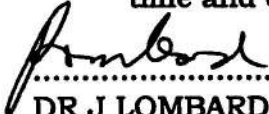

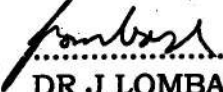

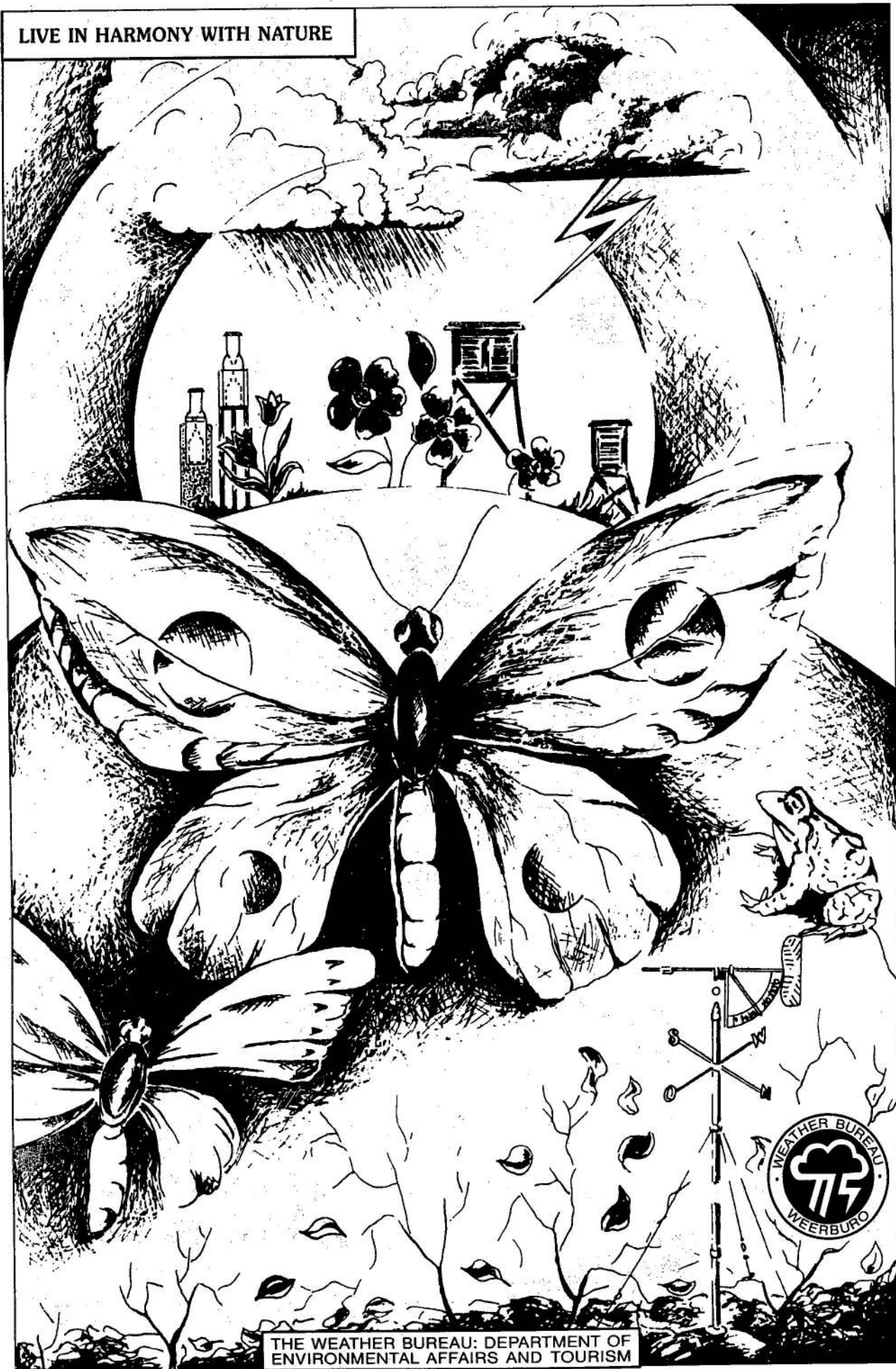
