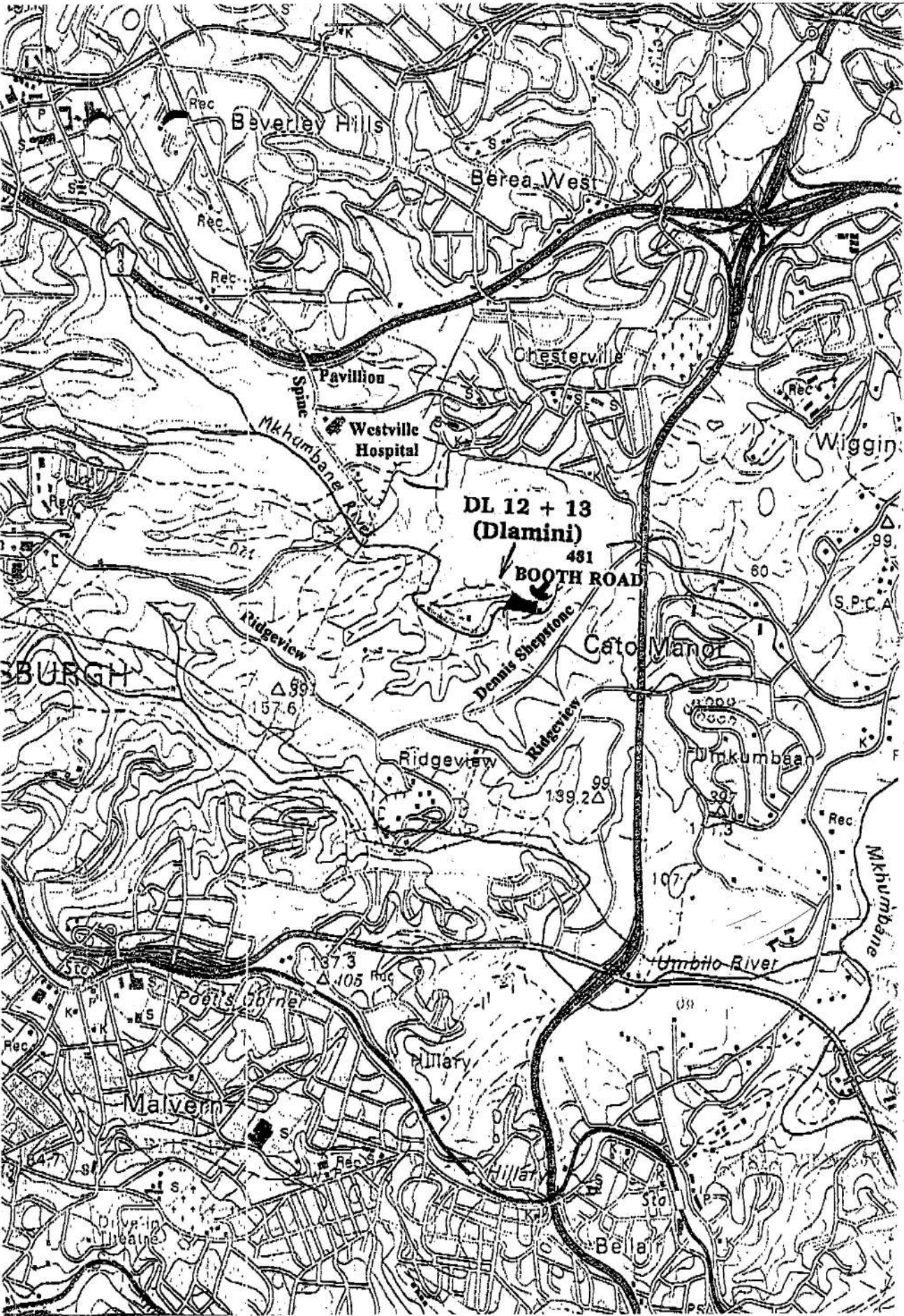

ACETAMINOPHENOL ORIGINATING IN THE REPUBLIC OF INDIA**

The Board on Tariffs and Trade received a petition requesting action against the alleged subsidised export of acetaminophenol originating in the Republic of India.

The Petitioner

The petition was lodged by Fine Chemicals Corporation (Pty) Ltd, the local manufacturer of the products in South Africa. The petitioner alleges that the Indian Government subsidises acetaminophenol in the form of a deduction equal to 100 per cent of the export profits in computing the company's taxable income.

The Product

The product being investigated is acetaminophenol, classifiable under tariff subheading 2924.29.90.

Subsidised export

The petitioner alleges that the Indian Government subsidises acetaminophenol in the form of an exemption of export profits from taxation. This was alleged to be a countervailable subsidy in accordance with the World Trade Organisation Agreement on Subsidies and Countervailing Measures.

Material injury (and/or threat thereof) and causality

The petitioner alleges that the domestic South African industry is suffering material injury (and/or threat thereof) owing to the importation from India of subsidised acetaminophenol in the form of price suppression, price depression, price undercutting, decline in sales and production and decline in profit.

Period of investigation

The period of investigation for purposes of determining the existence of a subsidy will be from June 1997 to May 1998. The period of investigation for purposes of determining injury will be for the years 1994/95, 1995/96, 1996/97 and for the period September 1997 to February 1998. If there are subsequent events that are relevant to injury the Board may later request and take into consideration further, more recent information.

Procedure

After unaccepted invitations for consultation with the Indian Government, and having decided that there is sufficient evidence to justify the initiation of an investigation, the Board has commenced an investigation in terms of section 4 of the Board on Tariffs and Trade Act, 1986. In order to obtain the information it deems necessary for its investigation, the Board will send questionnaires to the Indian Government, to all known importers and exporters, and known representative associations. Interested parties may submit their views in writing, preferably by completing the relevant questionnaire, and by submitting evidence supporting their replies. Parties may, by prior arrangement and if properly motivated, conduct informal discussions with the investigating officers and present further evidence. In such cases all information must subsequently be reduced to writing, if it is to be taken into consideration by the Board.

Where the position of a stockbroker or a compliance officer appointed in terms of 4.53.1, 4.53.2 or 4.53.3 becomes vacant, such position shall be filled within 2 months of its having become vacant.
- 4.53.5 For the purpose of this rule, the person in control of a place of business of a member shall be personally resident in the area where the place of business is located.

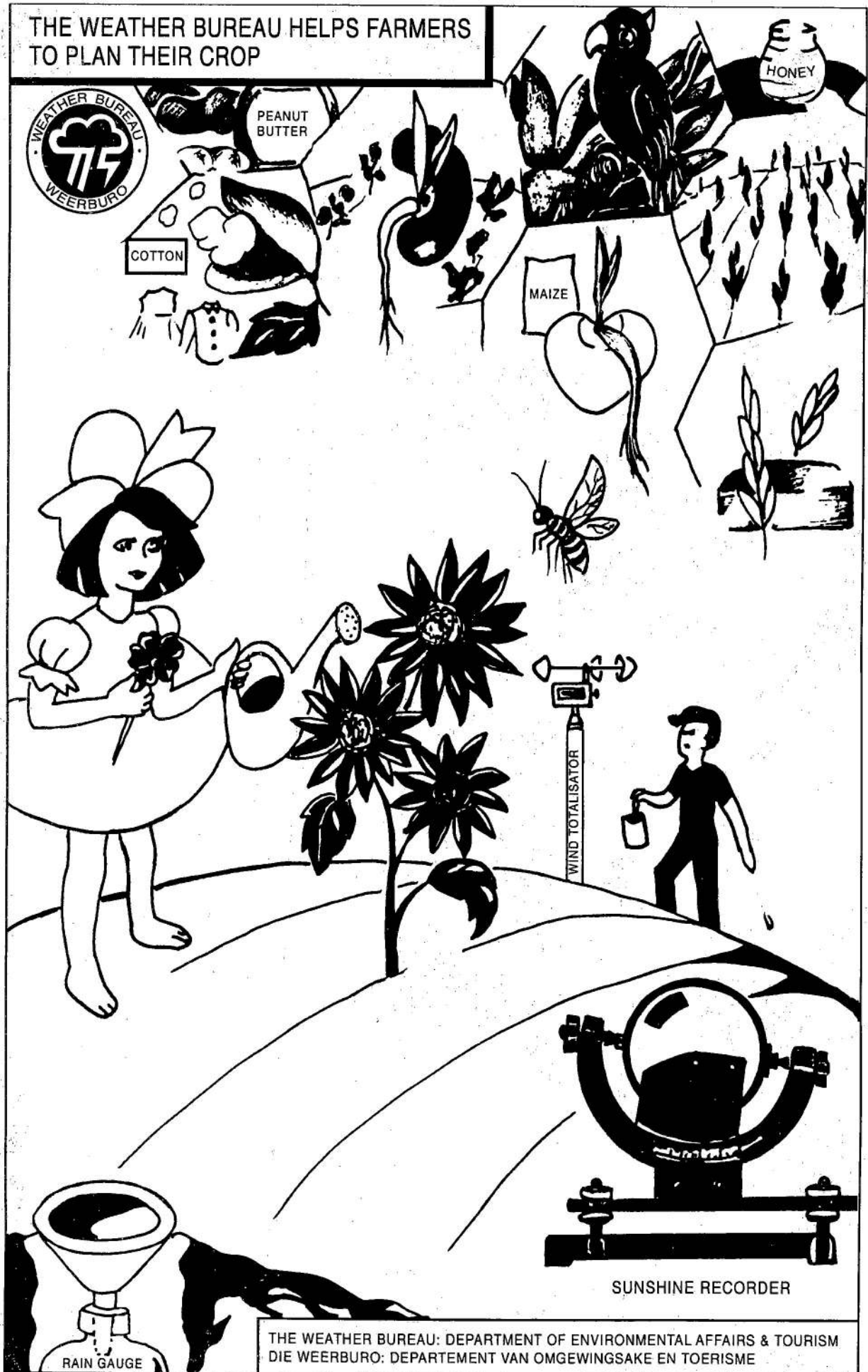

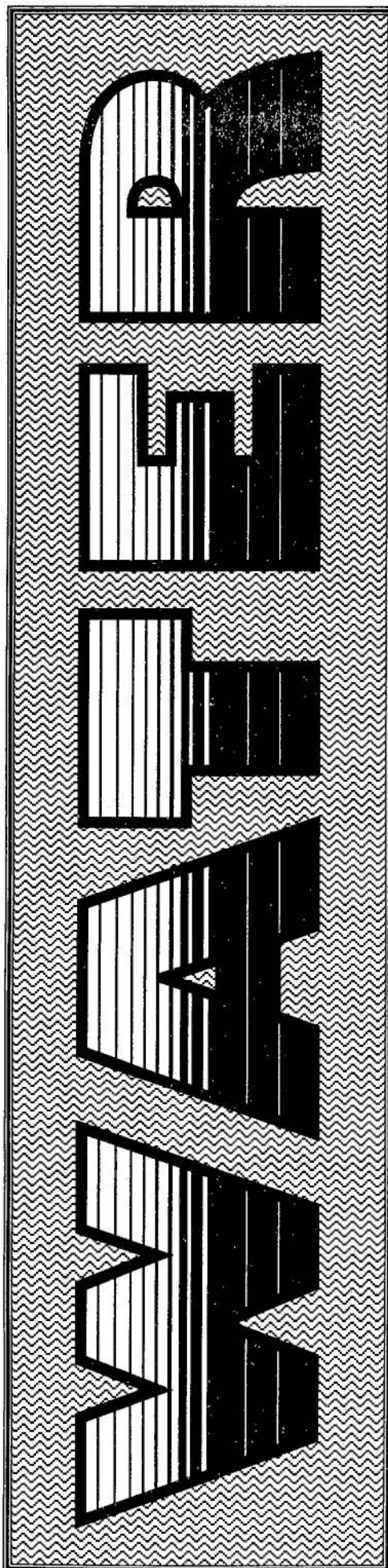
