RULES FOR CONDUCT OF PROCEEDINGS IN THE DEFENCE SPECIAL TRIBUNAL

The Rules Board has, in terms of section 159 (3) of the Labour Relations Act, No. 66 of 1995, read with section 5 of the Defence Special Tribunal Act, No. 81 of 1998, made the rules in the Schedule to regulate the conduct of proceedings in the Defence Special Tribunal.

SCHEDULE

1. The Rules of the Labour Court, published under Government Notice No. 1665 of 14 October 1995, as amended by Government Notice No. R. 961 of 11 July 1997, and Government Notice No. 1100 of 4 September 1998, and as amended from time to time, are, with the changes required by the context, and Rules 2 and 3 hereof, the Rules of the Defence Special Tribunal.

2. a party initiating proceedings in the Defence Special Tribunal, must—

- (a) where a dispute of fact is anticipated, follow the procedure laid down in Rule 6 of the Rules of the Labour Court; or
- (b) where a dispute of fact is not anticipated, follow the procedure laid down in Rule 7 of the Rules of the Labour Court.

3.

3.1 The parties must attempt to resolve the dispute by conciliation (including mediation, fact-finding or obtaining an advisory award with the assistance of a neutral third party if necessary). This must be done prior to the holding of a pre-trial conference or the set-down of an application for hearing.

3.2 The Court may refuse to determine any dispute if the Court is not satisfied that an attempt has been made to resolve the dispute through conciliation.

4. These Rules come into operation on the date that the Special Tribunal Act, No. 81 of 1998, comes into operation.




