### NOTICE OF A BY ELECTION OF A MEMBER OF THE SOUTH AFRICAN NURSING COUNCIL [SECTION 5 OF THE NURSING ACT, 1978 (ACT No. 50 of 1978)]

#### By-Election

1. In terms of the provisions of the Regulations relating to the election of members of the Council, published under Government Notice No. R. 1318 of 10 October 1997, notice is hereby given that an election of a member to serve on the Council for the unexpired period of the term of office of the members ending on 23 April 2003, is to be held.

#### Nomination of enrolled nursing auxiliaries

Each enrolled nursing auxiliary who is a South African citizen resident in the Republic shall be eligible for nomination.  
Each enrolled nursing auxiliary who is a South African citizen resident in the Republic, may sign not more than one (1) nomination.
