MINISTRY FOR PROVINCIAL AFFAIRS AND CONSTITUTIONAL DEVELOPMENT

THE DISESTABLISHMENT OF THE LOCAL GOVERNMENT AFFAIRS COUNCIL ACT, 1999.

1. I, Mohammed Valli Moosa, Minister for Provincial Affairs and Constitutional Development, under section 154 of the Constitution of the Republic of South Africa, 1996 (Act No. 108 of 1996), hereby publish the Disestablishment of the Local Government Affairs Council Act, 1999, for public comment.

DISESTABLISHMENT OF THE LOCAL GOVERNMENT AFFAIRS COUNCIL ACT, 1999**BILL**

To provide for the disestablishment of the Local Government Affairs Council, for the transfer of the assets, liabilities, rights, duties and obligations of that Council and to provide for matters connected therewith.

BE IT ENACTED by the Parliament of the Republic of South Africa, as follows:-

Definitions

1. In this Act, unless the context indicates otherwise-

“Council” means the Local Government Affairs Council established by section 2 of the Local Government Affairs Council Act (House of Assembly), 1989 (Act No. 84 of 1989);

Disestablishment of Council

2. Notwithstanding the provisions of any other law, the Council is hereby disestablished with effect from the date of coming into operation of this Act.

Transitional arrangements

3. The Minister for Provincial Affairs and Constitutional Development may after such consultation as he or she may deem fit, including consultation with the persons who were members or in the employ of the Council, make such arrangements as he or she may deem necessary for the finalisation of any matter, including financial matters, connected with the functions of the Council.

Repeal of laws

4. The Local Government Affairs Council Act (House of Assembly), 1989 (Act No. 84 of 1989), is hereby repealed with effect from the date of coming into operation of this Act.

Short title

5. This Act shall be called the Disestablishment of the Local Government Affairs Council Act, 1999.

Om voorsiening te maak vir die afskaffing van die Raad op Plaaslike Bestuursaangeleenthede, vir die oordrag van die bates, laste, regte, pligte en verpligtinge van daardie Raad en om voorsiening te maak vir aangeleenthede wat daarmee in verband staan.

DAAR WORD BEPAAL deur die Parlement van die Republiek van Suid-Afrika, soos volg:-

Woordomskrywing

1. In hierdie Wet, tensy uit die samehang anders blyk, beteken –

“Raad” die Raad op Plaaslike Bestuursaangeleenthede ingestel by artikel 2 van die Wet op die Raad op Plaaslike Bestuursaangeleenthede (Volksraad), 1989 (Wet No. 84 van 1989).

Afskaffing van Raad

2. Ondanks die bepalings van enige ander Wet, word die Raad hierby afgeskaf met effek van die datum waarop hierdie Wet in werking tree.

Oorgangsmatreëls

3. Die Minister vir Provinsiale Sake en Staatkundige Ontwikkeling kan na sodanige oorlegpleging as wat hy of sy goedvind, met inbegrip van oorlegpleging met die persone wat lede was of in diens van die Raad, sodanige matreëls tref wat hy of sy nodig ag vir die finalisering van enige aangeleentheid, met inbegrip van finansiële aangeleenthede, wat verband hou met die funksies van die Raad.

Herroeping van Wette

4. Die Wet op die Raad op Plaaslike Bestuursaangeleenthede (Administrasie: Volksraad), 1989 (Wet No. 84 van 1989) word hierby herroep met effek van die datum waarop hierdie Wet in werking tree.

Kort titel

5. Hierdie Wet heet die Wet op die Afskaffing van die Raad op Plaaslike Bestuursaangeleenthede, 1999.
