In terms of section 5 (1) (cD) of the National Monuments Act, 1969 (Act No. 28 of 1969), the National Monuments Council hereby declares the William Fehr Collection, as more fully described in the schedule hereto, to be a national cultural treasure because of its historical and cultural importance.

Description

The entire William Fehr Collection, consisting of furniture, ceramics, glass, silver, brass, wood, oil and water-colour paintings and drawings, as well as intaglio, relief and lithographic prints, photographs, plans and maps from the seventeenth to the nineteenth century and housed at Castle Good Hope and at Rust and Vreugd in Buitenkant Street, Cape Town.

**KRUGER NATIONAL PARK: EXCLUSION OF LAND FROM THE PARK AND DECLARATION OF LAND
TO BE PART OF THE PARK**

I, Zweledinga Pallo Jordan, Minister of Environmental Affairs and Tourism hereby—

- (a) under section 2A (2) of the National Parks Act, 1976 (Act No. 57 of 1976, hereinafter referred to "the Act")—
 - (i) and under the authority of a resolution of Parliament, exclude the land described in Schedule A hereto, from the Kruger National Park; and
 - (ii) amend the definition of the area of the said Park in Schedule 1 to the Act as indicated in Schedule B hereto;
- (b) under section 2B (1) (b) of the Act, declare the land described in Annexure C hereto to be part of the Kruger National Park; and
- (c) determine that—
 - (i) paragraph (a) shall commence immediately before the deed of grant in respect of the land referred to in paragraph (a) (i) is registered by the Registrar of Deeds in favour of the Makuleke Community;
 - (ii) paragraph (b) shall commence upon such registration.

SCHEDULE A

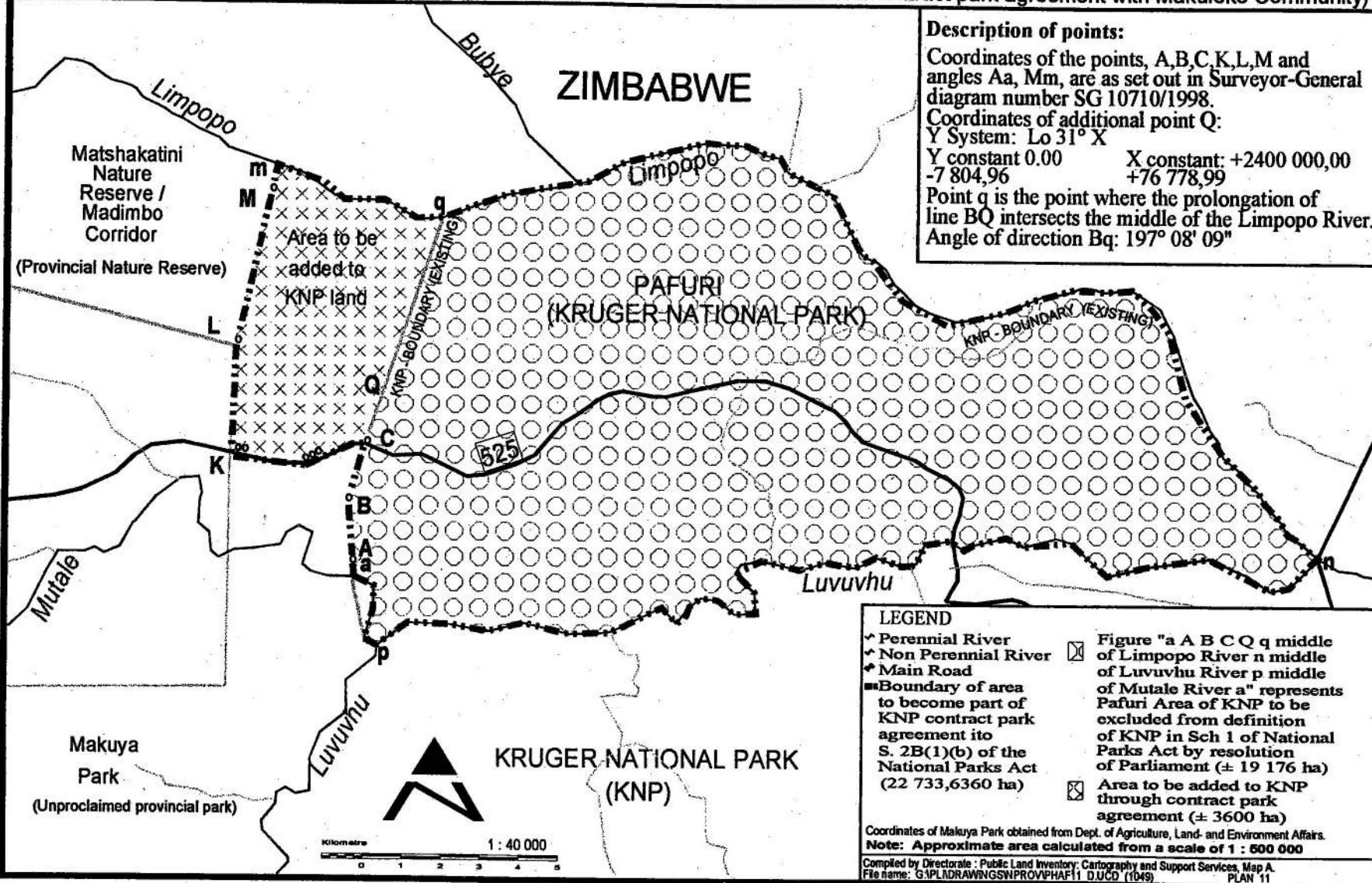

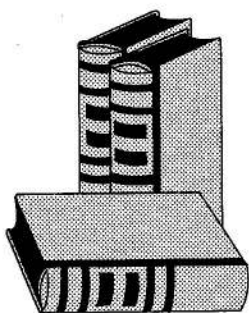
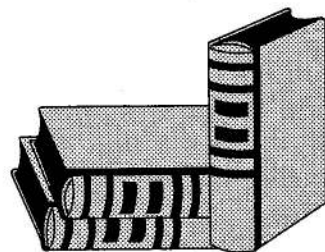
