1. Applicant is an existing bus operator between or along the routes in question.
2. This application involves route 26 and 28 in this way:
 - (a) Route 25 is an extension of 5 (five) kilometres from the existing starting point which was previously Ndukumbane because the need has been established that people from Bhiyela are walking long distances with their goods to Ndukumbane in wet conditions and sunny days. This practice has proved that this community is exposed to dangerous conditions and requested the applicant, whom they have been using for many years, to extend their service to meet their demand.
 - (b) Route 28 is change of starting point, the reason being, it is unreasonable for applicant to have a bus staying at Nongoma to travel 30 kilometres to the starting point so it is requested to start this bus from Nongoma to cut the cost of operating.

4. SERVICES TO BE PROVIDED

4.1 The service area

4.1.1 *Terrain and operating environment*

The roads used for bus routes in rural areas have gravel surfaces.

4.1.2 *Competitive modes of transport*

Competitive modes of public transport are taxis. They operate throughout the area.

4.1.3 *Private hire and contracts*

When vehicles are not required to operate according to the time table they may be used for other purposes including private hires or other contracts as well as on the casual routes mentioned under paragraph 3. Such commitments shall in no way relieve the Operator from operating the scheduled trips as provided in the timetables. Caution must be taken as the information contained in this document does not include private hires other contracts as well as casual routes.

4.1.4 *Scholars*

Scholars may use scheduled buses. Dedicated school trips have been omitted. A trip is deemed to be a dedicated school trip if more than 50% of the passengers are scholars.

4.2 Depots, terminals and bus parking

The existing bus stops and terminals authorised by the local authorities are to be used by the Operator.

The existing Operator (KwaZulu Transport (Pty) Ltd) uses a depot in Pietermaritzburg where the buses are kept and serviced during the day. During the night the buses stay in the rural areas. The tenderer should make his own arrangements for depots and the servicing, maintenance and parking of vehicles to be used for the contract.

4.3 Routes

4.3.1 *Route numbers*

4.4 Scheduling and Timetables

4.4.1 The timetables have been prepared for Mondays to Fridays. It has been estimated that initially 4 standard class buses are required to provide the service as indicated on the timetables included in Appendix A. The tenderer however should prepare his own estimate of the number of buses required to operate the services.

4.4.2 The timetables have been prepared assuming standard buses will be operated. However, if the tenderer proposes to operate other vehicle categories (with different passenger capacities), the tenderer must submit a revised timetable, indicating which type of vehicle is to be used on each trip. This shall constitute an alternative tender as contemplated in tender rule 15.
