SOUTH AFRICAN QUALIFICATIONS AUTHORITY ACT, 1995 (ACT NO. 58 OF 1995)

NOMINATION OF PERSONS TO SERVE AS MEMBERS OF THE SOUTH AFRICAN QUALIFICATIONS AUTHORITY (SAQA)

1. I Sibusiso Mandlenkosi Emmanuel Bengu, Minister of Education, in consultation with the Minister of Labour, hereby give notice in terms of *Section 4(4) of the South African Qualifications Authority Act, 1995 (Act No. 58 of 1995)*, hereafter referred to as the *SAQA Act*, and invite nominations of persons for appointment as members of the South African Qualifications Authority.

2. This Notice is concerned with the procedures for nominating all members of the Authority except, the chairperson and the executive officer. The post of member of SAQA is not a full-time appointment.

Nominations for members of SAQA

3. In *Section 4(3) of the SAQA Act*, a number of bodies or organisations are listed which are to provide nominations for membership of SAQA. Nominating bodies or organisations are required to submit the names of persons *who, on account of their experience and expertise in matters relating to the functions of the Authority may be suitable candidates for appointment, and due recognition is to be given to the principle of representivity*. Nominations marked Nominations for membership of SAQA should reach the address given in paragraph 8 below by **21 May 1999**, and should enclose a *curriculum vitae* and letter of consent by each candidate.
4. Bodies or organisations which are named in the *SAQA Act*, as well as the number of nominations required, are listed as follows:
 - (a) The Director-General: Education: one person;
 - (b) the Director-General: Labour: one person;
 - (c) the National Skills Authority (formerly the National Training Board); one person;
 - (d) the South African Universities' Vice-Chancellors' Association (formerly the Committee of University Principals): one person;
 - (e) the Committee of Technikon Principals: one person;
 - (f) the Heads of provincial education departments: one person.
5. National Bodies or organisations which are not named in the *SAQA Act*, but which represent sectors referred to in the Act, require recognition by the Minister for the purpose of making nominations. The following bodies or organisations are recognised for this purpose, and are requested to make the number of nominations provided for in the Act:
 - (a) The national bodies or organisations representing Organised Labour which are members of the Labour Caucus of the National Economic Development and Labour Council (NEDLAC): two persons;
 - (b) the national bodies or organisations representing Organised Business which are members of the Business Caucus of NEDLAC: two persons;

- (c) the Committee of Colleges of Education Rectors of South Africa (CCERSA): one person;
- (d) the Committee of Technical College Principals of South Africa (CTCP): one person;
- (e) the national bodies or organisations representing colleges other than teachers' colleges and technical colleges which are members of the College Sector Coalition and the College Sector Technical Committee of the National Commission on Higher Education: one person;
- (f) the national bodies or organisations representing the Adult Basic Education and Training sector which are members of the National Stakeholder Forum for Adult Basic Education and Training (ABET): one person;
- (g) the national bodies or organisations which are members of the Co-ordinating Committee for Early Childhood Development (ECD): one person;
- (h) the National Professional Teachers Organisation of South Africa (NAPTOZA) and the South African Democratic Teachers Union (SADTU): one person each;
- (i) the national bodies or organisations representing the Special Education Needs sector which are members of the National Co-ordinating Committee on Disability: one person;
- (j) national bodies or organisations representing lecturers and trainers which have been recognised by the Minister for this purpose: two persons.

The re-appointment of current members

6. Current members of bodies or organisations may in terms of *Section 6 of the SAQA Act* be re-appointed for a second term of office. Such bodies and organisations that wish to re-appoint their current members on the Authority for a further term of office, are invited to send requests in this regard by 21 May 1999 to the address given in paragraph 8 below, marked Requests for re-appointment by the Minister as members of SAQA.

Recommendation of candidates for discretionary appointment by the Minister

7. The *SAQA Act* allows the Minister to appoint not more than six members at his discretion. Any body or organisation whose interests are not otherwise covered by the *SAQA Act*, and which wishes to recommend a candidate for appointment by the Minister, is invited to submit such a recommendation, together with a *curriculum vitae* and a letter of consent from the candidate. Recommendations marked Discretionary Appointments to SAQA, should be received at the address given in paragraph 8 below, by **21 May 1999**.

WET OP DIE SUID-AFRIKAANSE KWALIFIKASIE-OWERHEID, 1995
(WET NO. 58 VAN 1995)

NOMINASIE VAN PERSONE OM TE DIEN AS LEDE VAN DIE SUID-AFRIKAANSE KWALIFIKASIE-OWERHEID (SAKO)

1. Ek, Sibusiso Mandlenkosi Emmanuel Bengu, Minister van Onderwys, in konsultasie met die Minister van Arbeid, gee hiermee kennis ingevolge *Artikel 4(4) van die Wet op die Suid-Afrikaanse Kwalifikasie-Owerheid, 1995 (Wet No. 58 van 1995)*, hierna verwys as die *SAKO-Wet*, en versoek nominasies van persone vir aanstelling as lede van die Suid-Afrikaanse Kwalifikasie-Owerheid.
2. Hierdie kennisgewing het betrekking op die procedures vir die nominasie van alle lede van die Owerheid, buiten die Voorsitter en die Uitvoerende Beampte. Die pos as 'n lid van SAKO is nie 'n voltydse aanstelling nie.

Nominasies vir lede van SAKO

3. In *Artikel 4(3) van die SAKO-Wet*, word 'n aantal liggome of organisasies gelys wat nominasies vir lede van SAKO moet indien. Nominasieliggome of organisasies word versoek om die name van persone wat uit hoofde van hulle ervaring en kundigheid oor aangeleenthede wat verband hou met die werksaamhede van die Owerheid, geskikte kandidate vir die aanstelling kan wees, voor te lê, en behoorlike erkenning te gee aan die beginsel van verteenwoordiging. Nominasies gemerk Nominasies vir lidmaatskap van SAKO moet die adres aangedui in paragraaf 8 hieronder teen **21 Mei 1999** bereik, en moet 'n *curriculum vitae* en toestemmingsbrief, geteken deur elke kandidaat, insluit.

4. Liggeme of organisasies wat in die *SAKO-Wet* genoem word, sowel as die aantal nominasies wat benodig word, is soos volg:
 - (a) Die Direkteur-Generaal: Onderwys: een persoon;
 - (b) die Direkteur-Generaal: Arbeid: een persoon;
 - (c) die Nasionale Vaardighedsowerheid (voorheen die Nasionale Opleidingsraad): een persoon;
 - (d) die Suid-Afrikaanse Universiteite Vise-Kanseliersvereniging (voorheen die Komitee van Universiteitshoofde): een persoon;
 - (e) die Komitee van Technikonhoofde: een persoon;
 - (f) die Hoofde van provinsiale onderwysdepartemente; een persoon.
5. Nasionale liggeme of organisasies wat nie in die *SAKO-Wet* genoem word nie, maar wat verteenwoordigend is van sektore genoem in die Wet, moet deur die Minister erken word, ten einde nominasies te kan voorlê. Die volgende liggeme of organisasies word erken vir hierdie doel en word versoek om die aantal nominasies waarvoor in die Wet voorsiening gemaak word, te voorsien:
 - (a) Die nasionale liggeme of organisasies verteenwoordigend van Georganiseerde Arbeid wat lede is van die Arbeidskoukus van die Nasionale Ekonomiese Ontwikkeling- en Arbeidsraad (NEDLAC): twee persone;
 - (b) die nasionale liggeme of organisasies verteenwoordigend van die Georganiseerde Sakesektor wat lede is van die Sakekoukus van NEDLAC: twee persone;
 - (c) die Komitee van Onderwyserskollegerektore van Suid-Afrika (KOKRSA): een persoon;
 - (d) die Komitee van Tegniesekollegehoofde van Suid-Afrika (KTKH): een persoon;
 - (e) die nasionale liggeme of organisasies verteenwoordigend van ander kolleges as onderwyserskolleges en tegniese kolleges wat lede is van die Kollegesektorkoalisie en die Kollegesektor Tegniese Komitee van die Nasionale Kommissie vir Hoër Onderwys: een persoon;

- (f) die nasionale liggeme of organisasies verteenwoordigend van die Volwassene-Basiese Onderwys- en Opleidingsektor wat lede is van die Nasionale Rolspelersforum vir Volwassene-Basiese Onderwys en Opleiding (VBOO): een persoon;
- (g) die nasionale liggeme of organisasies wat lede is van die Koördineringskomitee vir Vroeë Kinderontwikkeling (VKO): een persoon;
- (h) die Nasionale Professionele Onderwysersorganisasie van Suid-Afrika (NAPTOSA) en die Suid-Afrikaanse Demokratiese Onderwysunie (SADTU): een persoon elk;
- (i) die nasionale liggeme of organisasies verteenwoordigend van die Spesiale Onderwysbehoeftesektor wat lede is van die Nasionale Koördineringskomitee vir Ongeskiktheid: een persoon;
- (j) nasionale liggeme of organisasies verteenwoordigend van lektore en opleiers wat vir dié doel deur die Minister erken word: twee persone.

Die her-aanstelling van huidige lede

6. Huidige lede van liggeme of organisasies mag in terme van *Artikel 6 van die SAKO-Wet* heraangestel word vir 'n tweede termyn. Sodanige liggeme en organisasies wat verkies om hul huidige lede vir 'n verdere termyn weer aan te stel, se versoek moet gemerk wees, Versoek vir heraanstelling deur die Minister as lede van SAKO, en moet adres in paragraaf 8 hieronder aangedui, teen **21 Mei 1999** bereik.

Aanbevelings van kandidate vir aanstelling deur die Minister na goeddunke

7. Die *SAKO-Wet* maak voorsiening vir die Minister om nie meer as ses lede nie na goeddunke aan te stel. Enige liggaam of organisasie wie se belang nie andersins deur die *SAKO-Wet* aangespreek word nie, en wat 'n kandidaat wil aanbeveel vir aanstelling deur die Minister, word versoek om so 'n aanbeveling, tesame met 'n *curriculum vitae* en toestemmingsbrief van die kandidaat, in te dien. Aanbevelings gemerk Diskresionêre Aanstellings tot SAKO, moet die adres aangedui in paragraaf 8 hieronder teen **21 Mei 1999** bereik.
