PROHIBITION OF RESTRICTIVE PRACTICE IN TERMS OF SECTION 14 OF THE MAINTENANCE AND PROMOTION OF COMPETITION ACT, 1979 (ACT No 96 OF 1979)

I, Alec Erwin, Minister of Trade and Industry, issue this notice by virtue of the powers vested in me by section 14(1)(c) of the Maintenance and Promotion of Competition Act, 1979 (Act No 96 of 1979) (the Act) and determine that it will come into effect six weeks from the date of this notice.

This notice results from an investigation by the Competition Board to ascertain whether shareholding which Anesticum Limited, a company whose shareholding is limited to anaesthesiologists practising in South Africa, holds in Pulseline (Pty) Ltd (Pulseline), a medical device and medical supplies supplier constituted a restrictive practice as defined in section 1 of the Act (see Notice 267 in Government Gazette 17758 of 31 January 1997). The majority shareholder in Pulseline is Medhold Ltd (Medhold), a publicly quoted company.

In its Report No 62 the Competition Board found that (a) the restriction of the shareholding of Anesticum to practising anaesthesiologists, (b) that company's exclusive ties with Pulseline, and (c) Medhold's involvement in Pulseline, coupled with the influence which those anaesthesiologists have on the purchasing policies of the hospitals at which they practice and the financial rewards that will accrue to them if Pulseline prospers as a result of their support, has created a situation that places an unjustifiable limitation on the ability of Pulseline's competitors to compete effectively on the merits against it. This constitutes a restrictive practice as defined. The Board found no public interest justification for the structure which exists.

The Board's Report No 62 was sent to all the interested/affected parties with the invitation that they furnish me with their comments.

Having applied my mind to the matter, and taking into account the comments of all of the interested parties, I am satisfied that the Board's findings and recommendation in this regard are correct. Moreover, I am satisfied that it is not possible to enter into an arrangement with the parties to address the concerns which exist. For as long as practising anaesthesiologists hold a financial interest in a supplier of medical devices and medical supplies, the potential for anti-competitive behaviour will exist.

I therefore declare the situation to be unlawful, and order Medhold, Pulseline, Anesticum and the participating anaesthesiologists to take such action, either in terms of the Companies Act 1973 or any other law, as may be necessary to sever the links that Anesticum and the participating anaesthesiologists currently have with Medhold/Pulseline.

However, since the prohibition will require that shareholders should dispose of their shares, I direct that the parties may negotiate with the Competition Board to arrange a timetable for the disposal of the shares which would, in the opinion of the Competition Board, be reasonable under the circumstances, but in any event no longer than three months after the date of this notice.

SOUTH AFRICAN COUNCIL OF NATURAL SCIENTIFIC PROFESSIONS

The South African Council for Natural Scientific Professions herewith retract Board Notice 77 of 1997 as published on 29 August 1997 in *Government Gazette* No. 18221.

The South African Council for Natural Scientific Professions has under article 7 (k) of the Natural Scientific Professions Act, 1993 (Act No. 106 of 1993), determined the amended tariff of recommended fees in this Schedule, which has been approved.

SCHEDULE

Definitions

1. In this Schedule the definitions are as follows:

"Category A1" in respect of a private consulting practice in natural sciences, shall mean a top practitioner whose expertise is nationally or internationally recognised and who provides advice at a level of specialisation where such advice is recognised as that of an expert;

"Category A2", in respect of a private consulting practice in natural sciences, shall mean a partner, a sole proprietor, a director, or a member who, jointly or severally with his other partners, co-directors or co-members, bears the risk of the business, takes full responsibility for the liabilities of such practice, performs work of a conceptual nature in natural sciences and development, provides strategy guidance in planning and executing a project and/or carries responsibility for quality management pertaining to a project;

"Category B", in respect of a private practice in natural sciences, shall mean all salaried professional and technical staff performing work of a natural scientific nature and who carry the direct technical responsibility for one or more specific activities related to a project. A person referred to in Category A may also fall in this category if such person performs work of a natural scientific nature at this level;

"Category C", in respect of a private consulting practice in natural sciences, shall mean all other salaried technical staff performing work of a natural scientific nature under the direction and control of any person contemplated in Categories A or B.

RECOMMENDED FEES

"Category A1": A fee of 19,5 cents per hour per R100 or part thereof of the total costs of employment, or a fee of R600 per hour, whichever is the lesser;

"Category A2": A fee of 19,5 cents per hour per R100 or part thereof of the total cost of employment, or a fee of R490 per hour, whichever is the lesser;

"Category B": A fee of 17,5 cents per hour per R100 or part thereof of the total cost of employment, or a fee of R350 per hour, whichever is the lesser;

"Category C": A fee of 15,0 cents per hour per R100 or part thereof of the total cost of employment, or a fee of R281 per hour, whichever is the lesser.

This Schedule applies in respect of any stage of natural scientific service, which is started with on or after the date of publication of this Schedule.
