NOTICE OF INTENTION TO ERECT TOLL PLAZAS ON THE N3 AND TO DECLARE NATIONAL ROAD 3, SECTIONS 6X, 7X AND 8X BETWEEN KEEVERSFontein AND WARDEN A TOLL ROAD

In terms of section 27 (4) (a) of the South African National Roads Agency Limited and National Roads Act, 1998 (Act No. 7 of 1998), the Agency hereby gives notice of its intention to recommend to the Minister of Transport the declaration of that section of National Road 3 between KEEVERSFontein and Warden known as National Road 3, Section 6X, as declared by Government Notice No. 256 of 1980, being the road between the KEEVERSFontein interchange to Van Reenen, Section 7X, as declared by Government Notice No. 74 of 1979, being the road between Van Reenen to Harrismith South Interchange, Government Notice No. 2826 of 1990, being the Harrismith South Interchange, Government Notice No. 935 of 1989, being the Harrismith Eastern Bypass, Government Notice No. 61 of 1983, being the road between the end of the Harrismith Eastern Bypass to the left bank of the Meul River and Section 8X as declared by Government Notice No. 61 of 1983, being the road between the left bank of the Meul River to the Warden North Interchange, as a toll road.

In terms of section 27 (4) (a) (ii) of the said Act all interested persons are hereby invited to comment and make written representations, within 30 days from the date of notice, to the South African National Roads Agency Ltd, on the proposed declaration and position of the toll plazas. The representations in question are to be addressed to the Regional Manager: Eastern Region, South African National Roads Agency Ltd, P.O. Box 100410, Scottsville, 3209.

In terms of section 27 (4) (a) (i) of the said Act the approximate positions of the proposed toll plazas are given in the Annexure hereto.

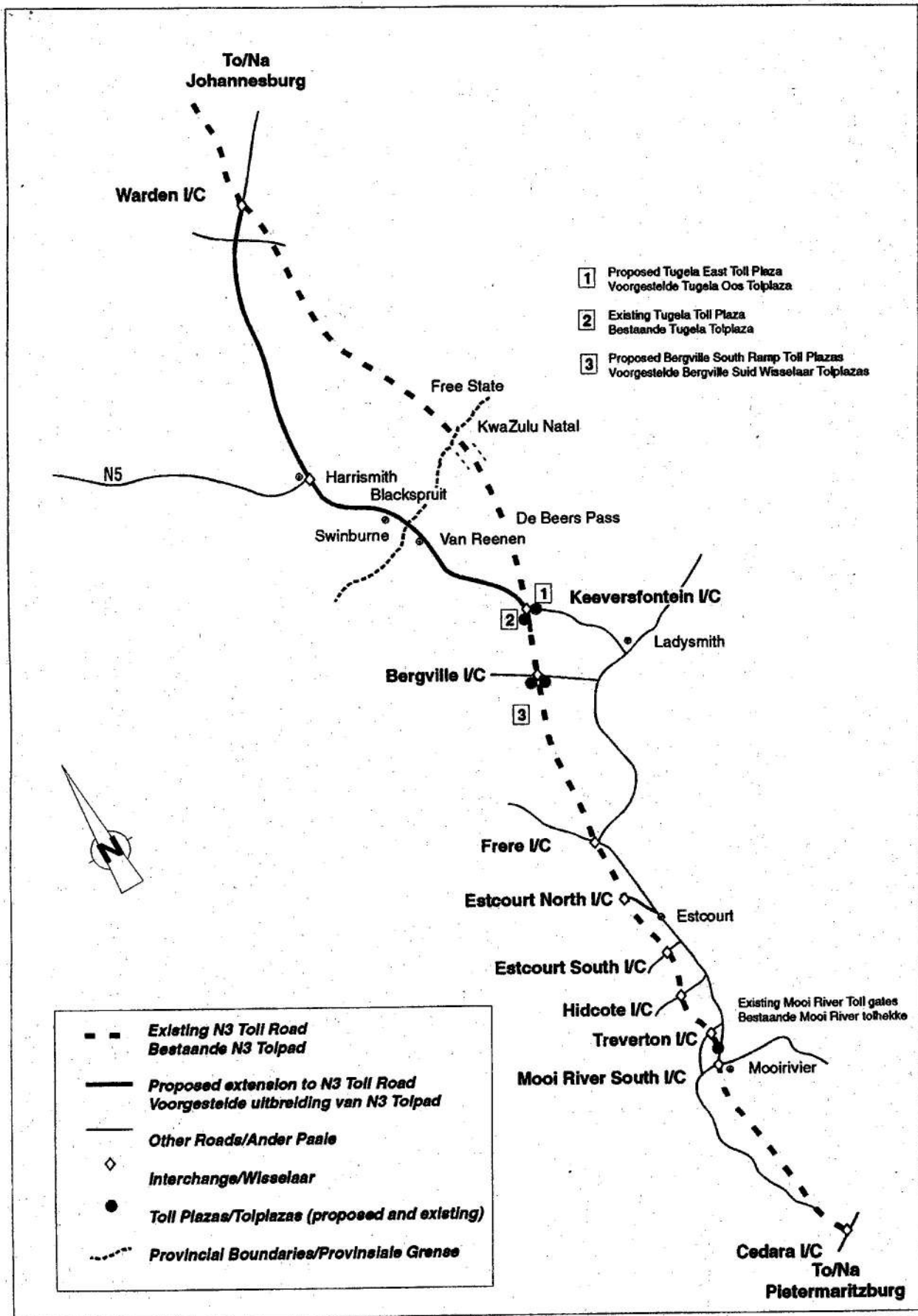
