INCREASE IN RESPECT OF SOCIAL GRANTS

The Minister for Welfare and Population Development has, in terms of the Social Assistance Act, 1992 (Act No. 59 of 1992), with the concurrence of the Minister of Finance, announced an increase in social grants.

The new maximum monthly amounts are as follows:

Care dependency	R500	R520
Foster child	R360	R374
Grant-in-aid.....	R 90	R 94

The increase will come into effect on 1 July 1999.
