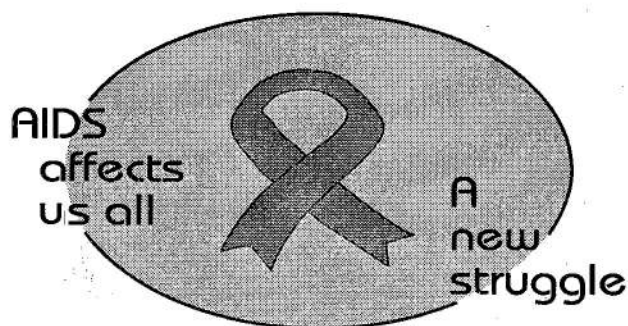

PROVISION OF LAND AND ASSISTANCE ACT, 1993: DESIGNATION OF CERTAIN LAND SITUATED IN THE DIVISION OF KOMGA, PROVINCE OF THE EASTERN CAPE

Under sections 2 (1) (c) and 2 (3) of the Provision of Land and Assistance Act, 1993 (Act No. 126 of 1993), I, Derek André Hanekom, Minister of Land Affairs, hereby designate—

Farm No. 200, in extent 46,0200 ha; and

Farm No. 348, in extent 14,3298 ha,

situated in the Division of Komga, Province of the Eastern Cape, for the purposes of settlement and hereby impose the following conditions for the use of the designated land:

- (i) The land will be held in undivided shares by Mntunaya James Makhoba, Nokhawunti Mambinja Makhoba, Nothandekile Makhoba, Netileni Makhoba and Lathiwe Makhoba (hereinafter referred to as the Owners).
- (ii) The Owners must ensure that the provisions of the Water Act, 1956 (Act No. 54 of 1956), and the Conservation of Agricultural Resources Act, 1983 (Act No. 43 of 1983), are complied with.
