

ALGEMENE KENNISGEWINGS****NOTICE 1993 OF 1999****UNIT TRUSTS CONTROL ACT, 1981****DETERMINATION OF MONEY MARKET INSTRUMENTS DENOMINATED IN
CURRENCIES OTHER THAN THAT OF THE REPUBLIC**

Under paragraph (c) of the definition of "securities" in section 1 of the Unit Trusts Control Act, 1981 (Act No. 54 of 1981), I, Richard Gray Cottrell, Registrar of Unit Trust Companies, hereby determine, after consultation with the Unit Trusts Advisory Committee, the money market instruments denominated in currencies other than that of the Republic, set out in the Schedule.

SCHEDULE

1. Money market instruments, which are denominated in a currency other than that of the Republic, that may be included in a money market unit portfolio are defined as follows:

"Money market instruments" mean a short term interest bearing instrument or deposit acknowledging indebtedness-

- 1.1 with an initial or residual maturity of less than 12 months; and

- 1.2 issued by an issuer domiciled in a country other than the Republic, which issuer or instrument issued by such issuer, has been rated by either Moody's Investors Service Limited with a rating of "A3" or "Prime2", or higher, or by Standard and Poor's with a rating of "A-" or "A-1", or higher: Provided that if the issuer or instrument has been rated by both agencies the lower of the ratings will apply.
2. The rating referred to in paragraph 1.2 must be a rating by one of the following rating agencies:
 - 2.1 Moody's Investors Service Limited; or
 - 2.2 Standard and Poor's.

1. Geldmarkinstrumente gedenomineer in ander betaalmiddels as die van die Republiek, wat in 'n geldmarkeffektegroep opgeneem mag word, word soos volg omskryf:

"Geldmarkinstrumente" beteken 'n korttermyn rentedraende instrument of deposito as skulderkenning -

- 1.1 met 'n aanvanklike of oorblywende termyn van hoogstens 12 maande; en
 - 1.2 uitgereik deur 'n uitreiker gedomisilieerd of gevestig in 'n ander land as die Republiek, welke uitreiker of instrument uitgereik deur sodanige uitreiker gegradeer is deur of Moody's Investors Service Limited met 'n gradering van "A3" of "Prima2", of hoër, of deur Standard and Poor's met 'n gradering van "A-" of "A-1", of hoër: Met dien verstande dat indien die uitreiker of die instrument deur beide agentskappe gegradeer is, die laagste van die graderings geld.
2. Die graderings in paragraaf 1.2 vermeld, moet 'n gradering wees deur een van die volgende graderingsagentskappe:
 - 2.1 Moody's Investors Service Limited; of
 - 2.2 Standard and Poor's

SCHEDULE

1. Money market instruments, in the currency of the Republic, that may be included in a money market unit portfolio, mean -

- (a) "banker's acceptance" a bill as defined in the Bills of Exchange Act, 1964 (Act No. 34 of 1964), drawn on and accepted by a bank as defined in the Banks Act, 1990 (Act No. 94 of 1990), or a mutual bank as defined in the Mutual Banks Act, 1993 (Act No. 124 of 1993);
- (b) "bridging bond" means an acknowledgement of debt in which the issuer thereof undertakes to repay the debt together with interest on the maturity of the debt to the holder of the bridging bond;

- (c) "commercial paper" any negotiable acknowledgement of debt;
- (d) "debenture" a debenture as defined in the Companies Act, 1973 (Act No. 61 of 1973);
- (e) "deposit" a deposit with a bank as defined in the Banks Act, 1990, or a mutual bank as defined in the Mutual Banks Act, 1993;
- (f) "land bank bill" a bill or note as defined in the Bills of Exchange Act, 1964, drawn, accepted or issued by the Land and Agricultural Bank of South Africa;
- (g) "national housing bill" a bill or note as defined in the Bills of Exchange Act, 1964, drawn, accepted or issued by the National Housing Board;
- (h) "negotiable certificate of deposit" a certificate of deposit issued by a bank as defined in the Banks Act, 1990, or a mutual bank as defined in the Mutual Banks Act, 1993, and payable to order or to bearer;
- (i) "parastatal bill" a bill or note as defined in the Bills of Exchange Act, 1964, drawn, accepted or issued by a parastatal institution;
- (j) "promissory note" a promissory note as defined in the Bills of Exchange Act, 1964;
- (k) "stock" loan stock as defined in section 1 of the Financial Markets Control Act, 1989 (Act No. 55 of 1989);

- (l) "trade bill" or "trade note" a bill or note as defined in the Bills of Exchange Act, 1964, drawn, accepted or issued to provide for the payment for goods;
- (m) "treasury bill" a bill drawn by the Government on the Secretary to the Treasury calling on the latter to pay a sum certain in money to a specified person or his order or to bearer, on demand or on a certain specified future date; and
- (n) "a deposit with, or any instrument of indebtedness (as defined under (a) to (m) above) issued by, a branch of a foreign institution which institution is authorised in terms of the Banks Act, 1990 (Act No. 94 of 1990), to conduct the business of a bank by means of such branch: Provided that the foreign institution must be from a country which has a foreign currency sovereign rating by either Moody's Investors Service Limited or Standard and Poor's of "A" or higher and the institution has a long-term credit rating of "A3" or "A-", respectively, or higher on the global scale by either Moody's Investors Service Limited or Standard and Poor's: Provided further that if the country or the foreign institution has been rated by both agencies the lower of the ratings will apply."

1. Die geldmarkinstrumente wat in 'n geldmarkeffektegroep opgeneem mag word word soos volg omskryf:
 - (a) "bankaksep" beteken 'n wissel soos omskryf in die Wisselwet, 1964 (Wet No. 34 van 1964), getrek op en geaktepteer deur 'n bank soos omskryf in die Bankwet, 1990 (Wet No. 94 van 1990), of 'n onderlinge bank soos omskryf in die Wet op Onderlinge Banke, 1993 (Wet No. 124 van 1993);
 - (b) "deposito" beteken 'n deposito by 'n bank soos omskryf in die Bankwet, 1990, of 'n onderlinge bank soos omskryf in die Wet op Onderlinge Banke, 1993;
 - (c) "effekte" beteken leningseffekte soos omskryf in die Wet op die Beheer van Finansiële Markte, 1989 (Wet No. 55 van 1989);
 - (d) "handelspapier" beteken 'n verhandelbare erkenning van skuld;
 - (e) "handelwissel" of "handelspromesse" beteken 'n wissel of promesse soos omskryf in die Wisselwet, 1964, getrek, geaktepteer of uitgereik om vir goedere te betaal;
 - (f) "landbankwissel" beteken 'n wissel of promesse soos omskryf in die Wisselwet, 1964, getrek, geaktepteer of uitgereik deur die Land- en Landboubank van Suid-Afrika;

- (g) "nasionale behuisingswissel" beteken 'n wissel of promesse soos omskryf in die Wisselwet, 1964, getrek, geaksepteer of uitgereik deur die Nasionale Behuisingsraad;
- (h) "oorbruggingsobligasie" beteken 'n erkenning van skuld waarin die uitreiker daarvan onderneem om op die vervaldag van die skuld die bedrag van die skuld plus rente aan die houer van die oorbruggingsobligasie te betaal;
- (i) "parastatale wissel" beteken 'n wissel of promesse soos omskryf in die Wisselwet, 1964, getrek, geaksepteer of uitgereik deur 'n parastatale liggaam;
- (j) "promesse" beteken 'n promesse soos omskryf in die Wisselwet, 1964;
- (k) "skatkiswissel" beteken 'n wissel getrek deur die Regering op die Sekretaris van die Tesourie waarin laasgenoemde opdrag gegee word om 'n vasgestelde bedrag geld aan 'n vermelde persoon of sy order of aan toonder, op aanvraag of op 'n vasgestelde toekomstige datum te betaal;
- (l) "skuldbrief" beteken 'n skuldbrief soos omskryf in die Maatskappywet, 1973 (Wet No. 61 van 1973);
- (m) "verhandelbare depositosertifikaat" beteken 'n depositosertifikaat uitgereik deur 'n bank soos omskryf in die Bankwet, 1990, of 'n onderlinge bank soos omskryf in die Wet op Onderlinge Banke, 1993, en betaalbaar aan order of aan toonder; en
- (n) "'n deposito by, of enige skuldinstrument (soos omskryf in (a) tot (m) hierbo) uitgereik deur 'n tak van 'n buitelandse instelling wat ingevolge die Bankwet, 1990 (Wet No. 94 van 1990), gemagtig is om die bedryf van 'n bank deur middel van sodanige tak uit te oefen: Met dien verstande dat die buitelandse instelling van 'n land moet wees met 'n vreemde valuta soewereine gradering deur óf Moody's Investors Service Limited óf Standard and Poor's van "A" of hoér en die instelling 'n langtermyn kredietgradering het van onderskeidelik "A3" of "A-", of hoér op die wêreldwye skaal deur óf Moody's Investors Service Limited óf Standard and Poor's: Met dien verstande verder dat indien die land of die buitelandse instelling deur beide agentskappe gegradeer is, die laagste van die graderings geld".
