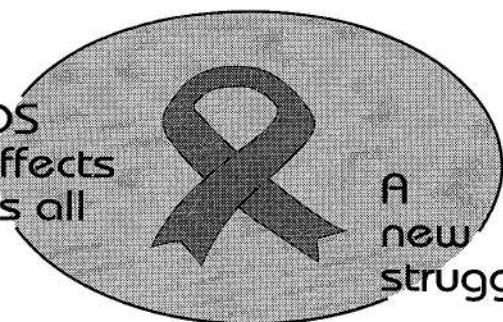

NOTICE 1996 OF 1999

DEPARTMENT OF TRADE AND INDUSTRY DEPARTEMENT VAN HANDEL EN NYWERHEID

INVITATION BY THE MINISTER OF TRADE AND INDUSTRY FOR NOMINATIONS OF PERSONS FOR APPOINTMENT AS CHAIRPERSON OF THE NATIONAL GAMBLING BOARD

In terms of section 3(3) of the National Gambling Act, 1996 (Act No. 33 of 1996), the Minister of Trade and Industry hereby invites nominations of persons as candidates for the Chairperson of the National Gambling Board as contemplated in section 3(1)(a) of the Act.

The person referred to in section 3(1)(a) shall be appointed only after the Minister of Trade and Industry has through the media and by notice in the Gazette invited nominations of persons as candidates for a position as the Chairperson of the Board, and the parliamentary committees concerned have made recommendations to the Minister in relation thereto after a transparent and open process of considering persons so nominated, having due regard to the objects of the National Gambling Act as set out in section 10 of the Act.

It must be emphasised that section 3(7)(a) of the Act stipulates that a person shall not be appointed as a member or remain to be a member of the Board -

- (i) unless he or she is a fit and proper person;
- (ii) if such a person, whether personally or through his or her spouse, partner or associate-
 - (aa) has or acquires a direct or indirect financial interest in any activity related to the objects of the Board; or
 - (bb) has or acquires any interest in any business or enterprise that may conflict or interfere with the proper performance of his or her duties as member of the Board;
- (iii) if such person-
 - (aa) is or becomes a political office-bearer;
 - (bb) is an unrehabilitated insolvent, or becomes insolvent and the insolvency results in the sequestration of his or her estate;
 - (cc) has at any time been, or is removed from an office of trust on account of misconduct; or
 - (dd) has at any time been or is convicted, whether in the Republic or elsewhere, of theft, fraud, forgery or uttering a forged document, perjury, an offence under the Corruption Act, 1992 (Act No. 94 of 1992), or any offence involving dishonesty.

Note that "political office-bearer" means a person as defined in section 190A of the Constitution of the Republic of South Africa, 1993 (Act No. 200 of 1993), including members of Provincial

Houses of Traditional Leaders, the Council of Traditional Leaders, the Volkstaat Council, and local government, and an official of any political party.

Nominations should be accompanied by a comprehensive curriculum vitae and a written statement in which the nominee declares whether or not he or she has any interests as referred to in section 3(7)(a)(ii) of the Act and whether or not he or she is disqualified for appointment in terms of section 3(7)(a)(iii) of the Act.

Please note that all nominees might at a later stage be requested to complete a questionnaire in order to determine substantiation of the suitability and eligibility of each nominee and the relevant committees of the Parliament of the Republic of South Africa will be empowered to interview nominees pursuant to section 3(3) of the National Gambling Act.

KENNISGEWING 1996 VAN 1999**UITNODIGING DEUR DIE MINISTER VAN HANDEL EN NYWERHEID VIR
NOMONASIES VAN PERSONE VIR AANSTELLING AS VOORSITTER VAN DIE
RAAD OP NASIONALE DOBBELRAAD**

Die Minister van Handel en Nywerheid nooi hiermee ingevolge artikel 3(3) van die Wet op Nasionale Dobbelarye, 1996 (Wet No. 33 van 1996), wat in werking is, nominasies uit van persone as kandidate vir aanstelling as Voorsitter van die Raad op die Nasionale Dobbelraad soos beoog in artikel 3(1)(a) van die Wet.

Die lede in artikel 3(1)(a) vermeld, word aangestel slegs nadat die Minister deur middel van die media en by kennisgewing in die Staatskoerant nominasies van persone vir kandidate as Voorsitter van die Raad versoek het en die betrokke Parlementere komitees met betrekking daartoe aanbevelings aan die Minister gemaak het, na 'n oop en deursigtige proses om sodanige genomineerde persone te oorweeg, met behoorlike inagneming van die oogmerke van die Raad soos in artikel 10 van die Wet uiteengesit.

Dit moet beklemtoon word dat artikel 3(7)(a) van die Wet bepaal dat iemand nie aangestel word of aanhou om lid van die Raad te wees nie-

- (i) tensy hy of sy 'n geskikte en gepaste persoon vir sodanige lidmaatskap is;
- (ii) indien sodanige persoon, hetsy persoonlik of deur sy of haar gade of lewesmaat, onmiddellike gesinslid, besigheidsvennoot of medewerker-
 - (aa) 'n regstreekse of onregstreekse finansiële belang het of verkry in enige aktiwiteit wat met die oogmerke van die Raad in verband staan; of
 - (bb) 'n belang het of verkry in enige saak of onderneming wat mag bots of inmeng met die behoorlike verrigting van sy of haar werksaamhede as 'n lid van die Raad;
- (iii) indien so 'persoon:
 - (aa) 'n politieke ampsdraer is of word;
 - (bb) 'n ongerehabiliteerde insolvent is, of insolvent word en die insolvensie uitloop op die sekwestrasie van sy of haar boedel;
 - (cc) te eniger tyd uit 'n vertrouensamp op grond van wangedrag ontslaan is of word; of
 - (dd) te eniger tyd skuldig bevind is of word, hetsy in die Republiek of elders, aan diefstal, bedrog, vervalsing of uitgifte van 'n vervalsing of uitgifte van 'n vervalsde stuk, meened, 'n oortreding kragtens die Wet op Korruptsie, 1992 (Wet No.94 van 1992), of enige misdryf waarby oneerlikheid betrokke is.

Neem kennis dat "politieke ampsbekleer" beteken dat 'n persoon soos omskryf in artikel 190A van die Grondwet van die Republiek van Suid-Afrika, 1993 (Wet No. 200 van 1993), met inbegrip van lede van die Provinsiale Huise van Tradisionele Leiers, die Raad van Tradisionele Leiers, die Volkstaatraad en 'n plaaslike regering en enige beampte van 'n politieke party.

Neem ook kennis dat alle genomineerdes in 'n latere stadium versoek mag word om 'n vraelys te voltooi ten einde substansie van die bevoegdheid en geskiktheid van elke genomineerde te verkry en die betrokke Parlementere komitees van die Republiek van Suid Afrika sodanige genomineerde persone te oorweeg ingevolge artikel 3(3) van die Nasionale Dobbeltwet.
