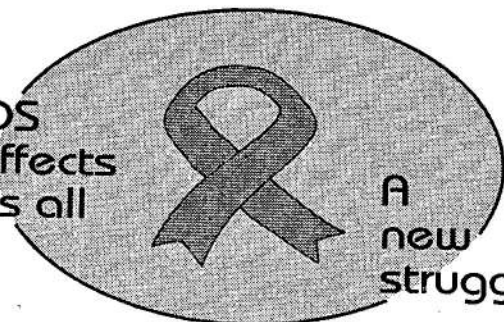

### NOTICE 2328 OF 1999

#### **NOMINATIONS FOR PERSONS TO BE APPOINTED BY THE MINISTER FOR WELFARE AND POPULATION DEVELOPMENT AS MEMBERS OF THE CENTRAL DRUG AUTHORITY**

#### **REQUEST FOR NOMINATIONS**

1. In terms of the provisions of Section 2 of the Prevention and Treatment of Drug Dependency Act, 1992 (Act No. 20 of 1992) as amended, nominations are requested for persons to be appointed by the Minister to serve on the Central Drug Authority. The main objective of the Central Drug Authority will be to give effect to the National Drug Master Plan and advise the Minister for Welfare and Population Development, and by implication the Government, on issues related to reducing both the supply of illegal drugs and the demand for them.
2. Nominations are invited for the appointment of persons who have special knowledge of or experience in the problem relating to the abuse of drugs or who are able to make a substantial contribution to the combating of such problem. It is expected from persons nominated to be familiar with the contents of the National Drug Master Plan and legislation which deals with issues relating to substance abuse. A detailed CV of each nominee must be submitted with the nomination which will reflect the person's knowledge and experience in respect of drug related issues.
3. Each candidate must be nominated separately and each nomination must be lodged with the Department of Welfare by post, fax or by hand before 12 November 1999.

4. A nomination which does not comply with the above requirements or which has not been lodged with the Ministry at the address stated below by the said date shall be invalid.
