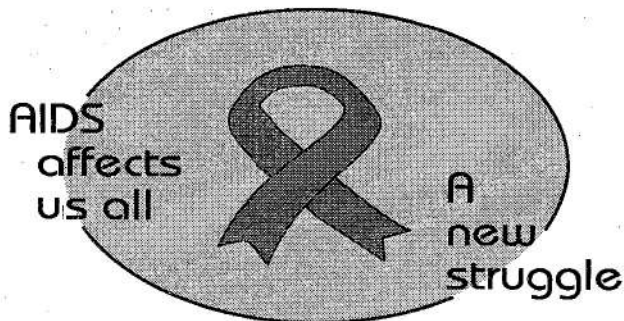

### UNEMPLOYMENT INSURANCE ACT, 1966

#### INCREASE OF THE MAXIMUM RATE OF EARNINGS BY VIRTUE OF WHICH A PERSON QUALIFIES AS A CONTRIBUTOR TO THE UNEMPLOYMENT INSURANCE FUND

Under section 2 (2) (d) of the Unemployment Insurance Act, 1966 (Act No. 30 of 1966), I Membathisi Mphumzi Shepherd Mdladlana, Minister of Labour, hereby amend the rate of earnings referred to in Government Notice No. 914 of 10 July 1998, from eighty eight thousand nine hundred and twenty rand per annum to ninety three thousand two hundred and eighty eight rand per annum with effect from 1 November 1999.
