

#### COMPETITION COMMISSION

#### NOTIFICATION OF PROPOSED TRANSACTION BETWEEN ALSTOM HOLDINGS (PTY) LTD, ALSTOM HOLDINGS (FRANCE) AND BARGENEL INVESTMENTS LIMITED

The Competition Commission hereby gives notice in terms of Rule 26 (8) (a) (iii) that Alstom Holdings (Pty) Ltd, has filed a notification with the Competition Commission on 4 November 1999, in terms of section 13 of the Competition Act, No. 89 of 1998, of the proposed sale of the 50% shareholding in it by Bargenel Investments Limited to Alstom Holdings (France).

Alstom Holdings (Pty) Ltd is currently owned 50% by Bargenel Investments Ltd, a wholly owned subsidiary of Reunert Ltd, and 50% by Alstom Holdings, a company registered in France. The effect of the transaction is that Alstom Holdings increases its stake in Alstom Holdings (Pty) Ltd from 50% to 100%.

The Competition Commission is evaluating the proposed transaction.

#### NOTIFICATION OF PROPOSED TRANSACTION BETWEEN ANGLO AMERICAN FARMS LIMITED AND BIZ AFRIKA 799 (PTY) LTD

The Competition Commission hereby gives notice in terms of Rule 26 (8) (a) (iii) that Anglo American Farms Ltd (Anglo Farms) has filed a notification with the Competition Commission on 1 November 1999, in terms of section 13 of the Competition Act, No. 89 of 1998, of the proposed sale of its canning, recipe dish and dairy businesses of its Food Division to Biz Afrika 799 (Pty) Ltd (Biz Afrika).

In terms of the proposed transaction Biz Afrika will acquire from Anglo Farms its canning, recipe dish and dairy businesses as a going concern. Biz will acquire the land, the factories, and other industrial and office buildings, all plant, equipment, furniture and fittings, stock, trademarks and intellectual property, livestock and sundry assets.
