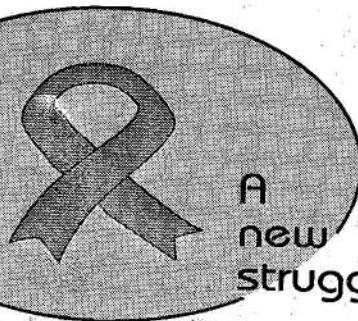

#### NOTICE OF PROPOSED ACQUISITION OF EDWARD NATHAN & FRIEDLAND INC. BY NEDCOR INVESTMENT BANK HOLDINGS LIMITED

The Competition Commission hereby gives notice in terms of rule 26 (8) (a) (iii) of the Rules for the Conduct of Proceedings in the Competition Commission, that on 4 November 1999, Edward Nathan & Friedland Incorporated, notified the Competition Commission, in terms of section 13 (1) of the Competition Act, No. 89 of 1998, of its proposed acquisition by Nedcor Investment Bank Holdings, a subsidiary of Nedcor Bank Limited.

In terms of the transaction, Edward Nathan & Friedland Inc. will sell and transfer to Nedcor Bank the Edward Nathan & Friedland business, excluding those divisions of Edward Nathan & Friedland Inc. which undertake litigation, conveyancing and company registrations, as a going concern. As a result of the proposed transaction, Nedcor Investment Bank Holdings Limited will acquire control over all the assets of the Edward Nathan & Friedland business.

The Competition Commission hereby gives notice in terms of rule 26 (8) (a) (iii) of the Rules for the Conduct of Proceedings in the Competition Commission, that on 1 November 1999, Viacom Inc., a company incorporated in the state of Delaware, USA, notified the Competition Commission, in terms of section 13 (1) of the Competition Act, No. 89 of 1998, of its proposed acquisition by CBS Corporation, a company incorporated in the State of Pennsylvania, USA.

In terms of the transaction, which was concluded off-shore, Viacom will acquire ultimate control of CBS. As a result of the proposed transaction, the separate corporate existence of CBS shall cease to exist and Viacom Inc. will be the surviving firm.
