

## QUOTAS FOR CITRUS FRUIT AND APPLE EXPORTS TO THE REPUBLIC OF CHINA (TAIWAN)

- In terms of the Bilateral Co-operation Agreement between the Republic of South Africa and Republic of China (Taiwan), South Africa may, subject to confirmation of the quantities by the Government of the Republic of China, export to the Republic of China, also known as Taiwan —
  - (a) a quantity of 1 000 tons of fresh citrus fruit (Citrus), namely grapefruit and oranges (Navels and Valencias), during the period 1 April 2000 to 31 August 2000; and
  - (b) a quantity of 1 200 tons of fresh apples (Malus) during the period 1 January 2000 to 31 December 2000.
- 2. All persons interested in exporting the products concerned to the Republic of China are hereby invited to apply in writing to the Director-General, National Department of Agriculture, Directorate: International Trade, Private Bag X791, PRETORIA, 0001, or submit applications by facsimile to fax no. (012) 326-6541 before 16h00 on Friday 17 December 1999. Applications must be marked for attention of Mr G.J. Kamfer (Directorate: International Trade). Inquiries may be directed to Mr G.J. Kamfer at telephone number (012) 319-6326 or fax number (012) 326-6541. No late applications will be considered.
- The allocation of quotas will be subject to the following conditions:
  - Quotas will be allocated on a pro rata basis in full container loads per allotment;

- (b) Quotas allocated to applicants may not be transferred; and
- (c) Quotas may only be utilised by the juristic person or individual to whom the National Department of Agriculture has allocated the quota.
- An application for the allocation of a quota must contain the following information:
  - (a) Name and address of applicant;
  - (b) Telephone and fax number of applicant;
  - (c) Description of product; and
  - (d) Quantity of product of export being applied for.
- 5. Applicants must comply with:
  - phytosanitary requirements as prescribed by the Government of the Republic of China; and
  - (b) all relevant provisions of the Agricultural Product Standards Act, 1990(Act No. 119 of 1990).

6. An application for the allocation of a quota for apples and citrus will only be considered if producers and exporters have been registered with the Directorate: Plant Health and Quality, National Department of Agriculture. Inquiries in this regard may be directed to Mr P. de Bruyn, tel. no. (012) 319-6346 or fax number (012) 319-6101.

- 7. An application for the allocation of a quota for apples will also only be considered once the results of the phytosanitary inspection of the orchards and the pack houses have been received by the Directorate: International Trade from the Director: Plant Health and Quality. An application for the issuing of a phytosanitary certificate for this purpose must contain the following information:
  - (a) Particulars of the orchard where the apples originate from; and
  - (b) Particulars of the pack houses to be used for the packing of apples.




