(7) *Authority*: Within the Republic of South Africa. *Subject to the conditions*: (a) No commuter services, intercity services and intertown services to be operated by the holder of this permit in terms of this authority from points referred to in the said authority to any other point referred to therein. (b) Once the vehicle has been hired by a group of passengers, the passengers shall be picked up as a group and set down as a group notwithstanding the fact that the pick-up point and the set-down point need not be the same point. (c) When tourists are being conveyed: (i) The driver of the vehicle must be in possession of a public driver's permit. (ii) A registered tour guide must accompany the tour; and (iii) They must be protected by valid passenger liability insurance cover of not less than one million rand. The conditions contained herein are subject to review at any time.
