

# NOTIFICATION OF PROPOSED TRANSACTION BETWEEN ENGEN LIMITED AND AFRIC ENERGY RESOURCES (PROPRIETARY) LIMITED

The Competition Commission hereby gives notice in terms of the rule 26 (8) (a) (iii) that Engen Limited ("Engen") has filed a notification with the Competition Commission on 17 November 1999, in terms of section 13 of the Competition Act, 1998 (Act No. 89 of 1998), of the proposed merger with Afric Energy Resources (Proprietary) Limited. The parties to this transaction are Petroliam Nasional Berhad, Petronas International Corporation Limited ("PICL"), Worldwide African Investment Holdings (Proprietary) Limited, Engen Limited and Afric Energy Resources (Proprietary) Limited. In terms of the transaction, Afric Energy Resources (Proprietary) Limited will buy 35 915 972 ordinary shares in Engen from PICL, representing 20 per cent of the entire issued share capital in Engen.
