# ACT

To provide for the disestablishment of the Local Government Affairs Council; to repeal the Local Government Affairs Council Act (House of Assembly), 1989 (Act No. 84 of 1989); and provide for matters connected therewith.

**B**E IT ENACTED by the Parliament of the Republic of South Africa, as follows:—

## **Disestablishment of Local Government Affairs Council**

1. The Local Government Affairs Council (hereinafter referred to as “the Council”) established by section 2 of the Local Government Affairs Council Act (House of Assembly), 1989 (Act No. 84 of 1989), is hereby disestablished. 5

## **Repeal of laws**

2. Subject to section 3, the Local Government Affairs Council Act (House of Assembly), 1989 (Act No. 84 of 1989), the Local Government Affairs Council Amendment Act (House of Assembly), 1991 (Act No. 45 of 1991), and the Local Government Affairs Council Amendment Act (House of Assembly), 1992 (Act No. 37 of 10 1992), are hereby repealed.

## **Transitional arrangements**

3. (1) The Minister for Provincial and Local Government may, after such consultation as may be necessary, which must include consultation with the persons who, immediately before the commencement of this Act, were members of the Council or in the employ of the Council, make such arrangements as may be necessary for winding up the affairs of the Council and for the finalisation of any matter, including matters relating to the employees, assets, liabilities, rights, obligations and finances of the Council. 15

(2) The Minister referred to in subsection (1) must pay any money left over after the winding up of the Council’s affairs into the National Revenue Fund. 20

## **Short title**

4. This Act is called the Disestablishment of the Local Government Affairs Council Act, 1999.

**Om voorsiening te maak vir die afskaffing van die Raad op Plaaslike Bestuurs-aangeleenthede; om die Wet op die Raad op Plaaslike Bestuursaangeleenthede (Volksraad), 1989 (Wet No. 84 van 1989), te herroep; en om voorsiening te maak vir aangeleenthede wat daarmee in verband staan.**

**D**AAR WORD BEPAAL deur die Parlement van die Republiek van Suid-Afrika, soos volg:—

### **Afskaffing van Raad op Plaaslike Bestuursaangeleenthede**

1. Die Raad op Plaaslike Bestuursaangeleenthede (hierna “die Raad” genoem) wat by artikel 2 van die Wet op die Raad op Plaaslike Bestuursaangeleenthede (Volksraad), 1989 (Wet No. 84 van 1989), ingestel is, word hierby afgeskaf.

### **Herroeping van wette**

2. Behoudens artikel 3 word die Wet op die Raad op Plaaslike Bestuursaangeleenthede (Volksraad), 1989 (Wet No. 84 van 1989), die Wysigingswet op die Raad op Plaaslike Bestuursaangeleenthede (Volksraad), 1991 (Wet No. 45 van 1991), en die Wysigingswet op die Raad op Plaaslike Bestuursaangeleenthede (Volksraad), 1992 (Wet No. 37 van 1992), hierby herroep.

### **Oorgangsmaatreëls**

3. (1) Die Minister vir Provinciale en Plaaslike Regering kan na die nodige oorlegpleging, wat oorlegpleging met die persone wat onmiddellik voor die inwerkingtreding van hierdie Wet lede van die Raad was of in diens van die Raad was, moet insluit, die nodige reëlings tref vir die afsluiting van die Raad se sake en die finalisering van enige aangeleentheid, met inbegrip van aangeleenthede wat verband hou met die werknemers, bates, laste, regte, verpligte en finansies van die Raad.  
20 (2) Die Minister bedoel in subartikel (1) moet enige geld wat na die afsluiting van die Raad se sake oor is, in die Nasionale Inkomstefonds inbetaal.

### **Kort titel**

4. Hierdie Wet heet die Wet op die Afskaffing van die Raad op Plaaslike Bestuursaangeleenthede, 1999.
